This is an application to increase and establish certain non-recurring charges for the Western Rockcastle Water Association. The adjustment is necessary to recover the cost of providing these customer caused expenses. Cost justification is included for each proposed charge.

A copy of the notice to be published is enclosed. The Association will publish the notice in accordance with Commission regulations and will provide verification that such notice has been given. A copy of this application has also been mailed to the Attorney General's Rate Intervention Division.

The Association has not had a general rate increase for several years and the Association does not anticipate filing for a general rate increase in the near future due to growth in the system. The Association believes it is unfair to all customers to not ensure that its non-recurring charges recover the expenses associated with providing the service. If the charge does not cover the costs, the other customers of the utility must pay the expenses.

Only those customers who cause the expense will be assessed the charge. The increase or the establishment of the charges will impact only existing customers. The Association requests the Commission use the most current annual report on file with the Commission to fulfill the requirement of 807 KAR 5:011, Section 1(e). Additional revenues to be generated will not exceed 5 percent of the total revenues provided by all miscellaneous and nonrecurring charges for the past 12 month period.
