This in response to the letter we received from the Commission rejecting the above referenced filing due to deficiencies. The cost justification for meter test requested by a customer is enclosed.

In reviewing the filing we noticed that the rate for the bulk sales was improperly stated. Enclosed is the corrected tariff sheet showing the correct rate for bulk sales of water.

The letter rejecting the filing also noted that a utility cannot increase its nonrecurring charges more than two times between general rate cases. While the district has filed 278.023 filings with the Commission it has not filed a general rate case or nonrecurring charge increases for several years. The District requests that the Commission treat this filing as a nonrecurring charge application instead of a general rate case. The District requests any filing deviations available to it in order for the Commission to process this case in a timely manner.




