
Pursuant to the scheduling order adopted by the Commission in this case, Intervenor Doug Doerrfeld requests that East Kentucky Power Cooperative, Inc. (EKPC) file with the Commission the following information, with a copy to all parties of record.

1. Has EKPC made application to any federal or state agency for any permits, licenses, authorizations or other approvals necessary for this proposed transmission line?
2. If the answer to Question 1 is "yes," please identify each application by date and agency to which application was made, and provide a copy of the application.
3. Please provide a copy of any studies that have been undertaken or commissioned by EKPC concerning alternative routes or alternative configurations for the proposed transmission line.
4. Does EKPC intend to acquire the necessary rights-of-way on a voluntary basis or through condemnation?
5. Please provide a copy of any studies that have been undertaken or commissioned by EKPC concerning alternative approaches to vegetation management for the proposed transmission line right-of-way.

6. Please identify by product name any herbicides or pesticides that will be used, if any, and the manner of application for the transmission line right-of-way.

7. Please provide a copy of any application that has been made to the Rural Utilities Service of the United States Department of Agriculture for any loan or other financial assistance for the proposed transmission line.

8. Please provide a copy of any studies, including any environmental impact statement or environmental assessment, produced by or on behalf of the Rural Utilities Service or other federal agencies, evaluating the environmental impacts of the proposed transmission line and alternatives.


