APPLICATION

Kentucky Power Company (Kentucky Power) moves the Commission pursuant to KRS 278.020(2), 807 KAR 5:001, Section 8, 807 KAR 5:001, Section 9 and 807 KAR 5:120 for a Certificate of Public Convenience and Necessity to Construct: (1) a 161 kV line; and, to the extent approval is required, (2) the Proposed Wooten Station in Leslie County, Kentucky.¹ In support thereof Kentucky Power states:

Applicant

1. Kentucky Power is an electric utility organized as a corporation under the laws of the Commonwealth of Kentucky in 1919. A certified copy of Kentucky Power's Articles of Incorporation and all amendments thereto was attached to the Joint Application in Case No. 99-149² as Exhibit 1. The post office address of Kentucky Power is 101A Enterprise Drive, P.O. 5190, Frankfort, Kentucky 40602-5190. Kentucky

Power is engaged in the generation, purchase, transmission, distribution and sale of electric power. Kentucky Power serves approximately 175,000 customers in the following 20 counties of eastern Kentucky: Boyd, Breathitt, Carter, Clay, Elliott, Floyd, Greenup, Johnson, Knott, Lawrence, Leslie, Letcher, Lewis, Magoffin, Martin, Morgan, Owsley, Perry, Pike and Rowan. Kentucky Power also supplies electric power at wholesale to other utilities and municipalities in Kentucky for resale. Kentucky Power is a utility as that term is defined at KRS 278.010

2. Kentucky Power is a wholly-owned subsidiary of American Electric Power Company, Inc. ("AEP.") The AEP System is a multi-state public utility holding company system that provides electric service to customers in parts of eleven states – Arkansas, Indiana, Kentucky, Louisiana, Michigan, Ohio, Oklahoma, Tennessee, Texas, Virginia and West Virginia.

The Proposed Project

3. Kentucky Power seeks authority to construct a 5,751 foot 161 kV transmission line and the Wooten Station in eastern Leslie County, Kentucky. The purpose of the line is to interconnect AEP's Hazard-Pineville 161 kV line and LG&E's Arnold-Delvinta 161 kV line.

(a) The proposed line will run between the planned AEP Wooten Station, which is near the existing Hazard-Pineville 161kV line, and Structure 391 of the LG&E Arnold – Delvinta 161kV line. The new line will be constructed on wood multi-pole structures using 795 MCM 26/7 ACSR phase conductors and 2- 7# 8 alumoweld static wires for protection. Kentucky Power will acquire a 125 foot wide right-of-way, with 62.5 feet on each side of the center line, in connection with the proposed transmission line.

(b) The Wooten Station is a new switching station to include three 161 kV circuit breakers, metering and associated facilities. System protection upgrades also will be constructed at remote stations.

4. The projected cost of the project is \$ 4,214,800. The proposed construction does not involve sufficient capital outlay to affect materially the financial condition of Kentucky Power. Construction will be financed through Kentucky Power's internally generated funds. After the proposed facilities are completed their estimated annual cost of operation are expected to be *de minimis* for the first several years.

5. The proposed transmission line will cross four parcels of property. In addition, at the tap structure in the LG&E line the right of way will cross two other parcels.

6. The Wooten Station will be constructed on an approximately 4.5 acre tract to be acquired from Tommy and Russell Baker. The Wooten Station will be located approximately 5,700 feet from the point where the AEP Hazard-Pineville 161 kV line and the LG&E Arnold-Delvinta 161 kV line cross in eastern Leslie County. The station is located approximately 100 feet north of Wooten creek on Wooten Creek Road (Rt. 1807.)

7. Kentucky Power is negotiating with the affected property owners for acquisition of the necessary property and right of ways. To date, Kentucky Power has obtained options to acquire four of the six tracts and rights of way required to construct the line and station.

**The Proposed Construction Is Required By The Public Convenience
And Necessity**

8. The Hazard Area of the Kentucky Power service territory is located in the eastern most portion of the Commonwealth and includes the Cities of Hazard, Hindman, Hyden, Jenkins and Whitesburg. The Beaver Creek-Hazard 138 kV line, the Hazard-Pineville 161 kV line and the Fleming-Collier 69 kV line supply an area load of over 350 MW. These are the only links that normally connect the Hazard Area to the remainder of the transmission system.

9. The Beaver Creek Station, located on the Beaver Creek-Hazard 138 kV line, connects the Hazard Area to the remainder AEP transmission system via several 138 kV transmission lines. The Pineville Station, located on the Hazard-Pineville 161 kV line, serves as a 161 kV interconnection point with the Tennessee Valley Authority system. The Hazard Station connects the 138 kV and the 161 kV networks via three single phase 45 MVA, 161/138 kV transformer units and also serves the local area sub-transmission load. The Beaver Creek Station is located 28 miles northeast of the Hazard Station.

10. Recent power flow studies for winter peak load conditions indicate that single-contingency outage conditions may load various facilities to levels above their winter capabilities. For example, a single contingency outage of the Leslie-Pineville 161 kV tie with TVA would result in thermally overloading the Beaver-Creek-Hazard 138 kV line up to 120 percent of its winter emergency capacity.

11. These same single contingency outages may produce extreme Hazard Area voltage concerns, including drops below 85% of nominal. Such voltage and thermal conditions may jeopardize service to over 350 MW of load in the Hazard Area.

12. Kentucky Power proposes to address these conditions by interconnecting with Louisville Gas & Electric Company's Arnold-Delvinta 161 kV line near where it crosses AEP's Hazard-Leslie 161 kV circuit of the Hazard-Pineville line. The interconnection will be provided by the proposed transmission line and station. The interconnection will provide an additional transmission resource into the Hazard Area and thereby provide single-contingency reliability to 350 MW of load in the Hazard Area, improve service and enhance single-contingency voltage conditions.

13. The proposed new construction will not compete with any public utilities, corporations or persons and will not result in duplication of facilities. The proposed new construction is required by the public convenience and necessity.

Route Selection Process

14. The general route for the transmission line is dependent upon the location of the proposed Wooten Station. Requirements for the station include proximity to the crossing of the LG&E and Kentucky Power 161 kV lines and at least one acre of relatively level surface to permit access by large trucks. Using a topographical map seven potential locations were identified. A field inspection eliminated five of the sites because of the proximity of existing homes, physical constraints of line construction to the site, limited or no access to the site by heavy equipment or the large amounts of fill required to raise the site above the flood plain.

15. Kentucky Power identified two potential sites for the station. It first contacted the owner of the site closer to the line crossing. That owner declined, on two separate occasions, to sell the site to Kentucky Power because it was his only location for a garden.

16. Kentucky Power has entered into a written option agreement with the owner of the second site. It is located approximately 5,700 feet from the transmission line crossing. Kentucky Power also has reached agreement with the owners of the site for a transmission right of way across their property.

NOTICES

17. By letters dated and mailed first class mail, postage prepaid, on June 17, 2005 Kentucky Power notified all property owners over whose property the transmission right of way is proposed to cross (as indicated by the records of the Leslie County Property Valuation Administrator), as well as the owners of the right of way associated with the tap structure. Included within the letters were:

- (a) notice of the proposed construction;
- (b) the docket number (2005-00101) under which the application will be processed;
- (c) the address and telephone number of the Commission's Executive Director;
- (d) a description of the property owners' rights to request a public hearing and to right to request intervention;
- (e) a description of the project and a map of the proposed route of the line.

Copies of the letters, the list of the persons to whom they were mailed, their addresses as indicated by the records of the Leslie County Property Valuation Administrator and the verification by Errol K. Wagner of the mailing of the letters are attached as **EXHIBIT 3**.

18. A notice of Kentucky Power's intent to construct the line, along with the information required by 807 KAR 5:120, Section 2(5), was published in *The Leslie County News*, a paper of legal record and general circulation for Leslie County, on June 9, 2005. The text of the notice, map and affidavit of publication are filed herewith as **EXHIBIT 4**.

(a) Three maps of no less than one inch equals 1,000 feet of the proposed project showing the location of the proposed transmission center line, the right of way, boundaries of each property to be crossed by the line as indicated by the records of the Leslie County Property Valuation Administrator. **[EXHIBIT 1]** Because the routing was determined after the location of the Wooten Station was fixed and because of the relatively short length of the line, no alternate routes were considered;

(b) Sketches of the typical transmission line support structures.

(c) Granting Kentucky Power such other relief as may be appropriate.

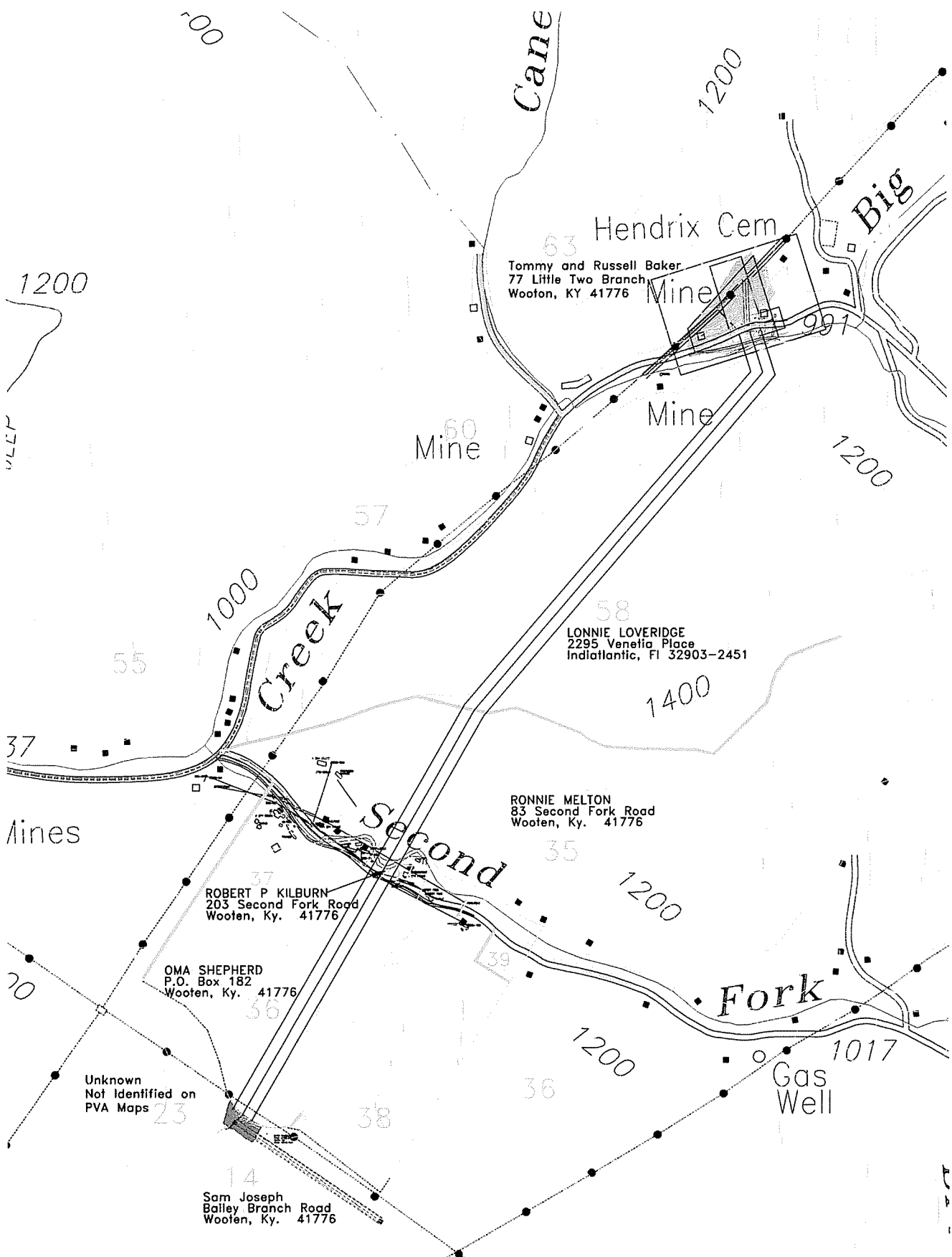

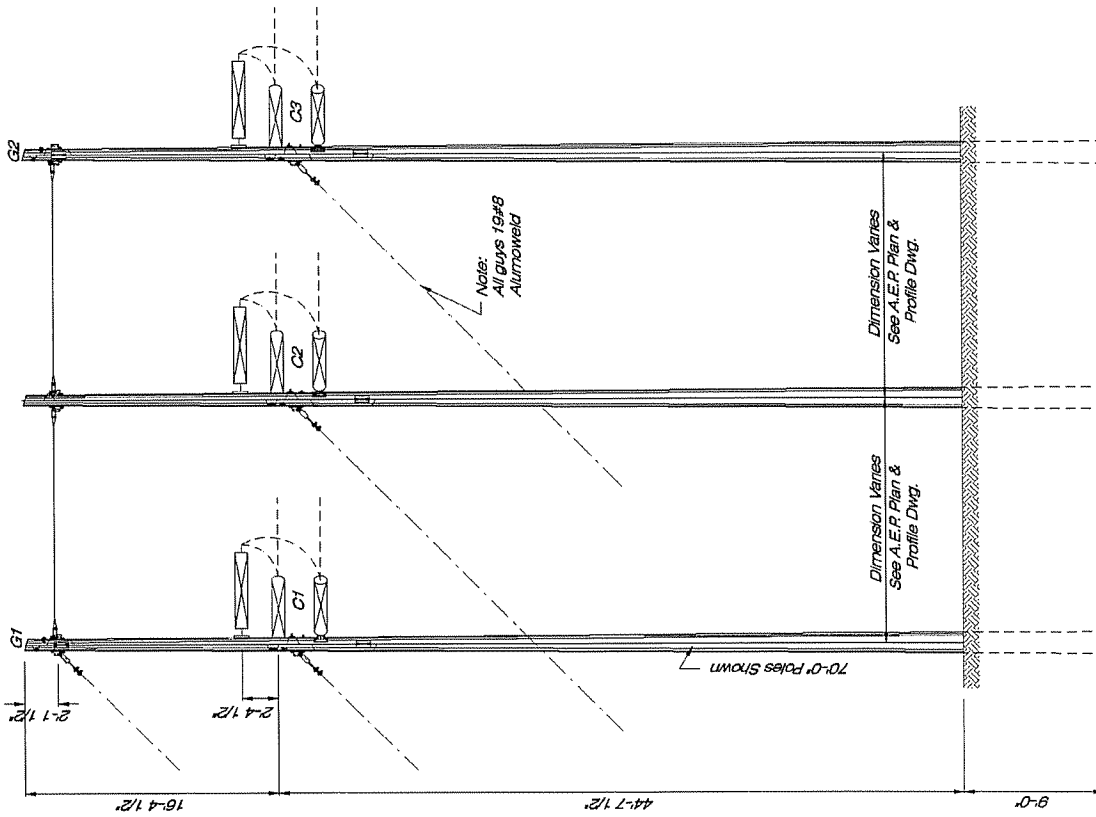
*Alternate Shield Wire

This notice is provided to you pursuant to 807 KAR 5:120, Section 2(3). As you are aware, Kentucky Power Company (KPCo) proposes to construct a 161-kV transmission line, a portion of which will cross your property. You have been contacted by KPCo's representatives for the necessary right-of-way.

This entire new line will be approximately 6,000 feet in length will run between KPCo's Leslie 161-kV line and Kentucky Utilities' Arnold-Delinta 161-kV line crossing. A map of the proposed line is enclosed. The line will provide the single-contingency reliability and improve service to the customers in the Hazard area.

KPCo may construct the line only after receiving a Certificate of Public Convenience and Necessity (CCN) from the Kentucky Public Service Commission (KPSC). You have the right to request a local public hearing to consider KPCo's request for a CCN. Your request must be in writing and addressed to Elizabeth O'Donnell, Executive Director, KPSC 211 Sower Boulevard, P.O. Box 615, Frankfort, Kentucky 40602-0615 or call 502/564-3940. The request also should contain:


- (a) The docket number of this proceeding (Case No. 2005-00101);
- (b) Your name, address and telephone number;
- (c) A statement whether you wish to participate in any evidentiary hearing or to make an unsworn public statement concerning the proposed application.

The written request must be received by the Commission within thirty days of the date of this letter, which is the date KPCo filed its application with the Commission for the CCN to construct the line.

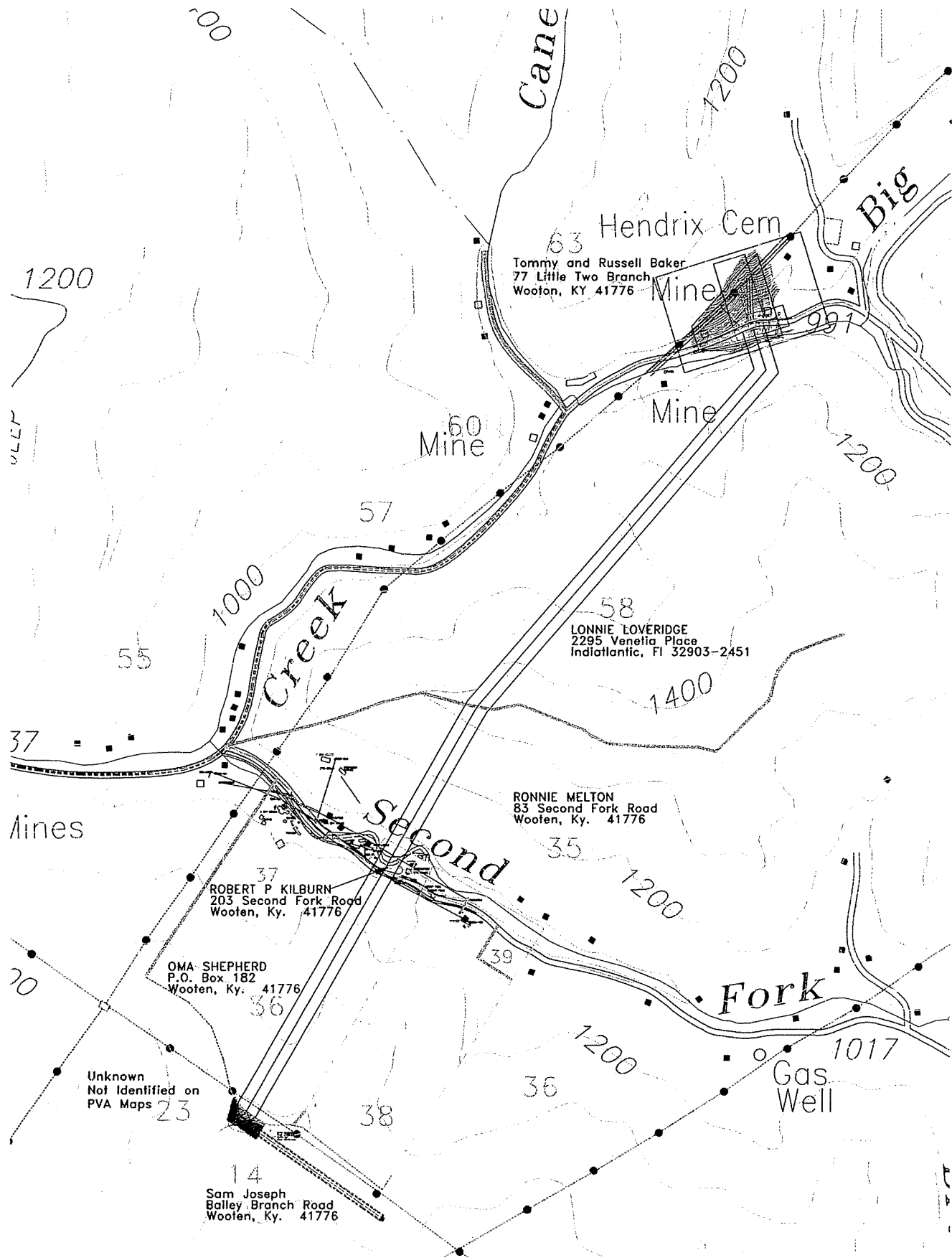
You also have the right to intervene as a party to the proceedings in accordance with 807 KAR 5:001, Section 3(8), a copy of which is enclosed.

807 KAR 5:001. Rules of procedure.

RELATES TO: KRS Chapter 278

STATUTORY AUTHORITY: KRS 278.310(2)

NECESSITY, FUNCTION, AND CONFORMITY: KRS 278.310(2) provides that all hearings and investigations before the commission or any commissioner shall be governed by rules adopted by the commission. This administrative regulation prescribes requirements with respect to formal and informal proceedings before the commission.

Section 1. General Offices and Hearings. (1) The commission will be in continuous session for the performance of administrative duties.

(2) Meetings of the commission for the consideration of all matters requiring formal hearings will be held on such days, at such hours and at such places as the commission may designate.

(3) Notice of hearing will be given by the secretary to parties to proceedings before the commission, except when a hearing is not concluded on the day appointed therefor and verbal announcement is made by the presiding commissioner or hearing examiner of an adjourned date. Verbal announcements so made shall be deemed due notice of continued hearing.

Section 2. Secretary to Furnish Information. (1) Upon request, the secretary will advise any party as to the form of a petition, complaint, answer, application or other paper desired to be filed; and he will make available from the commission's files, upon request, any document or record pertinent to any matter before the commission.

(2) The secretary may reject for filing any document which on its face does not comply with the rules and administrative regulations of the commission.

Section 3. General Matters Pertaining to All Formal Proceedings. (1) Address of the commission. All communications should be addressed to "Public Service Commission, Frankfort, Kentucky."

(2) Case numbers and styles. Each matter coming formally before the commission will be known as a case and will receive a number and style, descriptive of the subject matter. Such number and style shall be placed on all subsequent papers in such case.

(3) Form of papers filed. All pleadings and applications filed with the commission in formal proceedings shall be printed or typewritten on one (1) side of the paper only, and typewriting shall be double spaced.

(4) Signing of pleadings. Every pleading of a party represented by an attorney shall be signed by at least one (1) attorney of record in his individual name and shall state his address. Except when otherwise specifically provided by statute, pleadings need not be verified or accompanied by affidavit.

(5) Amendment. At its discretion, the commission may allow any complaint, application, answer or other paper to be amended or corrected or any omission supplied therein.

(6) Witnesses and subpoenas.

(a) Upon the application of any party to a proceeding, subpoenas requiring the attendance of witnesses for the purpose of taking testimony may be signed and issued by a member of the commission.

(b) Subpoenas for the production of books, accounts, papers or records (unless directed to issue by the commission on its own authority) will be issued only at the discretion of the commission, or any commissioner, upon application in writing, stating as nearly as possible the books, accounts, papers or records desired to be produced.

(7) Service of process. When any party has appeared by attorney, service upon such attorney will be deemed proper service upon the party.

(8) Intervention and parties. In any formal proceeding, any person who wishes to become a party to a proceeding before the commission may by timely motion request that he be granted leave to intervene. Such motion shall include his name and address and the name and address of any party he represents and in what capacity he is employed by such party.

(a) Each person granted leave to intervene shall be considered as making a limited intervention unless he submits to the secretary a written request for full intervention. A person making only a limited intervention shall be entitled to the full rights of a party at the hearing in which he appears and shall be served with the commission's order, but he shall not be served with filed testimony, exhibits, pleadings, correspondence and all other documents submitted by parties. A person making a limited appearance will not be certified as a party for the purposes of receiving service of any petition for rehearing or petition for judicial review.

(b) If a person granted leave to intervene desires to be served with filed testimony, exhibits, pleadings, correspondence and all other documents submitted by parties, and to be certified as a party for the purposes of receiving service of any petition for rehearing or petition for judicial review, he shall submit in writing to the secretary a request for full intervention, which shall specify his interest in the proceeding. If the commission determines that a person has a special interest in the proceeding which is not otherwise adequately represented or that full intervention by party is likely to present issues or to develop facts that assist the commission in fully considering the matter without unduly complicating or disrupting the proceedings, such person shall be granted full intervention.

Dear Sir or Madam:

This notice is provided to you pursuant to 807 KAR 5:120, Section 2(3). As you are aware, Kentucky Power Company (KPCo) proposes to construct a 161-kV transmission line, a portion of which will cross your property. You have been contacted by KPCo's representatives for the necessary right-of-way.

This entire new line will be approximately 6,000 feet in length will run between KPCo's Leslie 161-kV line and Kentucky Utilities' Arnold-Delinta 161-kV line crossing. A map of the proposed line is enclosed. The line will provide the single-contingency reliability and improve service to the customers in the Hazard area.

KPCo may construct the line only after receiving a Certificate of Public Convenience and Necessity (CCN) from the Kentucky Public Service Commission (KPSC). You have the right to request a local public hearing to consider KPCo's request for a CCN. Your request must be in writing and addressed to Elizabeth O'Donnell, Executive Director, KPSC 211 Sower Boulevard, P.O. Box 615, Frankfort, Kentucky 40602-0615 or call 502/564-3940. The request also should contain:


- (a) The docket number of this proceeding (Case No. 2005-00101);
- (b) Your name, address and telephone number;
- (c) A statement whether you wish to participate in any evidentiary hearing or to make an unsworn public statement concerning the proposed application.

The written request must be received by the Commission within thirty days of the date of this letter, which is the date KPCo filed its application with the Commission for the CCN to construct the line.

You also have the right to intervene as a party to the proceedings in accordance with 807 KAR 5:001, Section 3(8), a copy of which is enclosed.

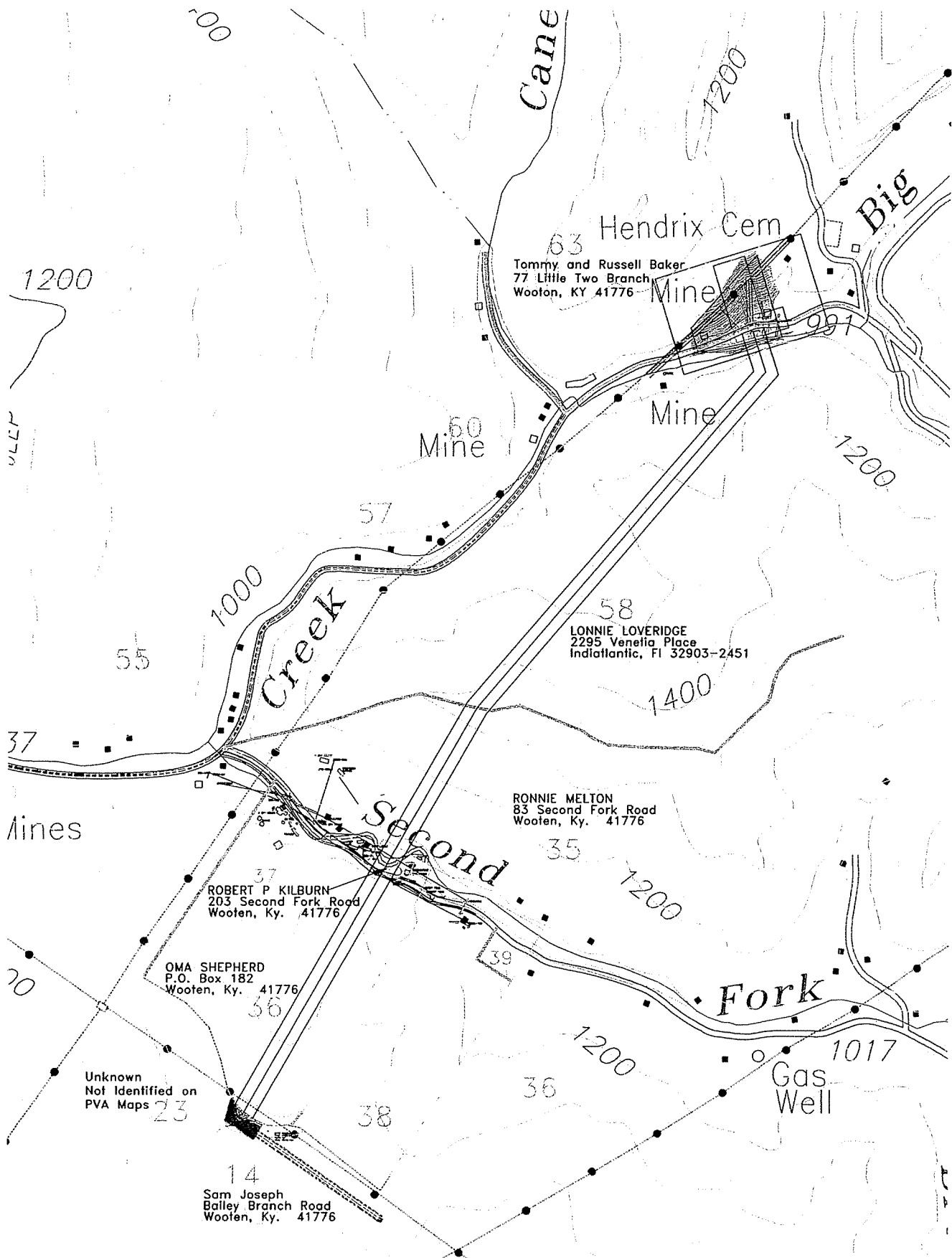

807 KAR 5:001. Rules of procedure.

RELATES TO: KRS Chapter 278

STATUTORY AUTHORITY: KRS 278.310(2)

NECESSITY, FUNCTION, AND CONFORMITY: KRS 278.310(2) provides that all hearings and investigations before the commission or any commissioner shall be governed by rules adopted by the commission. This administrative regulation prescribes requirements with respect to formal and informal proceedings before the commission.

Section 1. General Offices and Hearings. (1) The commission will be in continuous session for the performance of administrative duties.

(2) Meetings of the commission for the consideration of all matters requiring formal hearings will be held on such days, at such hours and at such places as the commission may designate.

(3) Notice of hearing will be given by the secretary to parties to proceedings before the commission, except when a hearing is not concluded on the day appointed therefor and verbal announcement is made by the presiding commissioner or hearing examiner of an adjourned date. Verbal announcements so made shall be deemed due notice of continued hearing.

Section 2. Secretary to Furnish Information. (1) Upon request, the secretary will advise any party as to the form of a petition, complaint, answer, application or other paper desired to be filed; and he will make available from the commission's files, upon request, any document or record pertinent to any matter before the commission.

(2) The secretary may reject for filing any document which on its face does not comply with the rules and administrative regulations of the commission.

Section 3. General Matters Pertaining to All Formal Proceedings. (1) Address of the commission. All communications should be addressed to "Public Service Commission, Frankfort, Kentucky."

(2) Case numbers and styles. Each matter coming formally before the commission will be known as a case and will receive a number and style, descriptive of the subject matter. Such number and style shall be placed on all subsequent papers in such case.

(3) Form of papers filed. All pleadings and applications filed with the commission in formal proceedings shall be printed or typewritten on one (1) side of the paper only, and typewriting shall be double spaced.

(4) Signing of pleadings. Every pleading of a party represented by an attorney shall be signed by at least one (1) attorney of record in his individual name and shall state his address. Except when otherwise specifically provided by statute, pleadings need not be verified or accompanied by affidavit.

(5) Amendment. At its discretion, the commission may allow any complaint, application, answer or other paper to be amended or corrected or any omission supplied therein.

(6) Witnesses and subpoenas.

(a) Upon the application of any party to a proceeding, subpoenas requiring the attendance of witnesses for the purpose of taking testimony may be signed and issued by a member of the commission.

(b) Subpoenas for the production of books, accounts, papers or records (unless directed to issue by the commission on its own authority) will be issued only at the discretion of the commission, or any commissioner, upon application in writing, stating as nearly as possible the books, accounts, papers or records desired to be produced.

(7) Service of process. When any party has appeared by attorney, service upon such attorney will be deemed proper service upon the party.

(8) Intervention and parties. In any formal proceeding, any person who wishes to become a party to a proceeding before the commission may by timely motion request that he be granted leave to intervene. Such motion shall include his name and address and the name and address of any party he represents and in what capacity he is employed by such party.

(a) Each person granted leave to intervene shall be considered as making a limited intervention unless he submits to the secretary a written request for full intervention. A person making only a limited intervention shall be entitled to the full rights of a party at the hearing in which he appears and shall be served with the commission's order, but he shall not be served with filed testimony, exhibits, pleadings, correspondence and all other documents submitted by parties. A person making a limited appearance will not be certified as a party for the purposes of receiving service of any petition for rehearing or petition for judicial review.

(b) If a person granted leave to intervene desires to be served with filed testimony, exhibits, pleadings, correspondence and all other documents submitted by parties, and to be certified as a party for the purposes of receiving service of any petition for rehearing or petition for judicial review, he shall submit in writing to the secretary a request for full intervention, which shall specify his interest in the proceeding. If the commission determines that a person has a special interest in the proceeding which is not otherwise adequately represented or that full intervention by party is likely to present issues or to develop facts that assist the commission in fully considering the matter without unduly complicating or disrupting the proceedings, such person shall be granted full intervention.

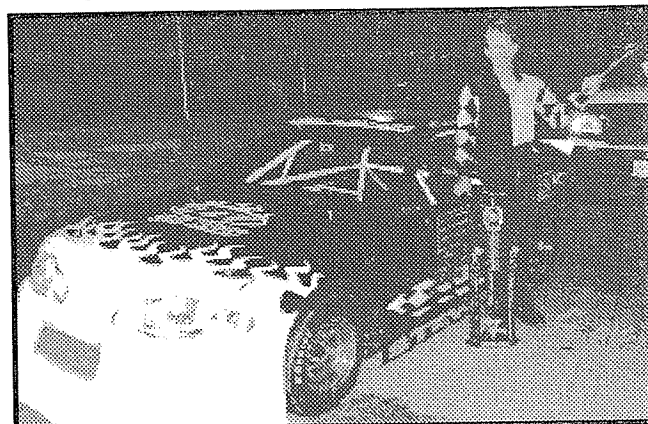

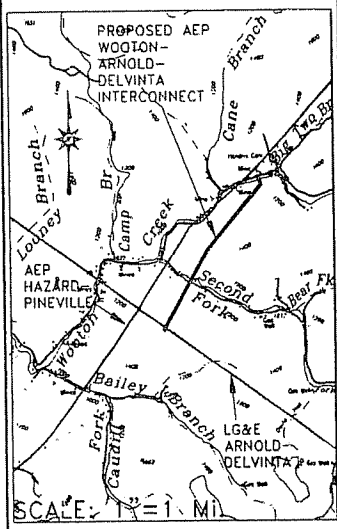
