**RESPONSE OF KENTUCKY UTILITIES COMPANY
TO CONCERNED CITIZENS' REQUESTS FOR CLARIFICATION**

Applicant, Kentucky Utilities Company ("KU"), respectfully submits this response to the filing of the Concerned Citizens Against Power Line Extension ("Citizens") styled "Request for Clarification of KU's Responses to Data Requests" in this proceeding. That filing, made on July 19, 2005, seeks "clarifications" which are, in fact, follow-up or new data requests which are not provided for by the Commission's existing procedural schedule in this matter. In addition to the fact that further discovery is not permitted under that schedule, many, if not all, of these requests would require input from individuals who are presently involved in the hearing before the Commission in Case No. 2003-00266 and thus not available. For these reasons, KU states that it will not provide responses to these "clarification" requests at this time, but that its witnesses will be prepared to respond to those requests at the scheduled hearing on July 26, 2005 should these same questions be asked.

With regard to "clarification" request No. 4, relating to original request No. 8, however, KU states that it did inadvertently fail to directly respond to the second half of that original request. A supplemental response is filed herewith.

Finally, with regard to “clarification” request No. 9, relating to original request No. 19, which request seeks clarification on a legal objection, KU, by counsel, responds that the original objection had multiple grounds, including that the request was overly burdensome. With regard to that specific portion of the objection, however, KU states that it would take significant time and effort to compile the requested information, which is not relevant to the subject matter of this proceeding nor reasonably calculated to lead to the discovery of admissible evidence, for all of its right of way in those three counties. KU has already produced maps showing the locations of its transmission facilities in the area as part of this proceeding.


