Specific regulations and limitations for this promotion are as follows:

- 2. Customers must place their orders on or before August 31, 2005.
- 3. Transfer orders must be successfully completed by September 23, 2005 to be eligible.
- 4. Limit of one (1) Target® Gift Card per BellSouth customer account.
- 5. Within four to six weeks (4-6) after the online order has completed, a redemption e-mail, which includes a mail-in coupon, will be distributed to the customer's e-mail address that was submitted with the online order.
- 6. Coupon postmark deadline is ninety (90) calendar days from the order completion date to be eligible.
- 7. Orders submitted at BellSouth.com that are cancelled before implemented are not eligible.

- 15. Customers who order DIRECTV® in a separate transaction will not receive the forty-five dollar (\$45.00) offer (they will receive the existing thirty-five dollar (\$35.00) offer).
- 16. Offer is available to BellSouth employees.

# BELLSOUTH TELECOMMUNICATIONS, INC.'S MOTION FOR EXPEDITED TREATMENT

BellSouth Telecommunications, Inc. ("BellSouth"), by counsel, pursuant to KRS 278.180(2), moves the Commission for expedited treatment of its promotion offer described in the attached letter and states in support of this motion as follows:

BellSouth files herewith a notice of its intent to offer a new promotion called the Consumer eStore Movers DIRECTV® Offer effective May 1, 2005. This promotion offers existing customers an incentive to transfer their service via BellSouth.com. The proposed effective date of May 1, 2005, does not allow for the normal 30-day review process.

Kentucky law allows the Commission to approve a shortened time period in which a reduction in rates may be made. KRS 278.180(2).

BellSouth requests that the Commission approve BellSouth's request to offer this promotion to qualified residential

customers in Kentucky beginning on May 1, 2005. If the Commission grants this motion for expedited treatment, BellSouth will be able to have this promotion effective in Kentucky in the same manner that it is planned to be offered in the other eight states in BellSouth's region. This promotion is a benefit to qualified customers, and it would be advantageous for qualified Kentucky customers to have the opportunity of the promotion at the same time that customers in BellSouth's other states are able to participate in this promotion.

As this Commission noted in its April 29, 2003, Order in Case No. 2002-00276, Petition of BellSouth Telecommunications, Inc. for Presumptive Validity of Tariff Filings, the Commission was in agreement with BellSouth's desire to get products and services and lower prices to the public more expeditiously. Therein, the Commission encouraged BellSouth, as well as other telecommunications carriers, to take advantage, on a case by case basis, of the existing provisions of KRS 278.180.

For the foregoing reasons, BellSouth respectfully requests that the Commission grant its Motion for Expedited Treatment and permit the proposed promotion to be effective on May 1, 2005.
