
This letter is written to respond to your memorandum of April 23, 2007, attaching a memorandum of the informal conference held April 12, 2007, and asking for any comments regarding that memorandum.

On page 2 of the memorandum, the last sentence in the first paragraph reads:

“Counsel for Big Rivers conceptually agreed with Staff’s assessment and said that Big Rivers would file a separate application pursuant to KRS 278.020 to obtain a new CPCN.”

I believe what I said was that Staff’s assessment may well be correct, but that one reason for the request that the case be held in abeyance for sixty days was to allow Big Rivers to determine what use could be made of the proceedings held to date to avoid duplication of expense and effort. One alternative Big Rivers is studying is whether and to what extent, a CPCN can be assigned. I did say that any application regarding the transmission project required pursuant to KRS 278.020 would be filed separately from the anticipated application in Big Rivers’ “unwind transaction.” A copy of this letter has been served upon all parties of record in this proceeding.
