I reviewed the detailed map that you provided to me regarding the East Kentucky Power Company transmission line.


I am sure you realize this but this line is proposed directly in my front yard. It will take out all the landscaping and all of the trees. I have 59.25 acres and it even appears to me if the line went straight instead of making a 20 degree turn to go directly in my front yard, and in fact taking the left front corner of my house, it would be easier. I really need the entire map of this project to see all the turns, if you could so kindly provide me with one.

This house and the 5 acres surrounding it has been appraised for \$400,000.00. The estimated value of this area if a transmission line is in my front yard is \$0.00. I am greatly concerned. There is acres and acres of land very near, just a few yards off that has no homes and is just woods. This area seems more appropriate to me.

It is also my understanding that East Kentucky Power will not be providing electricity for any additional members than is already being served now and that the cost of electricity will not go down as a result of this project. Am I correct in this?
If not please explain.

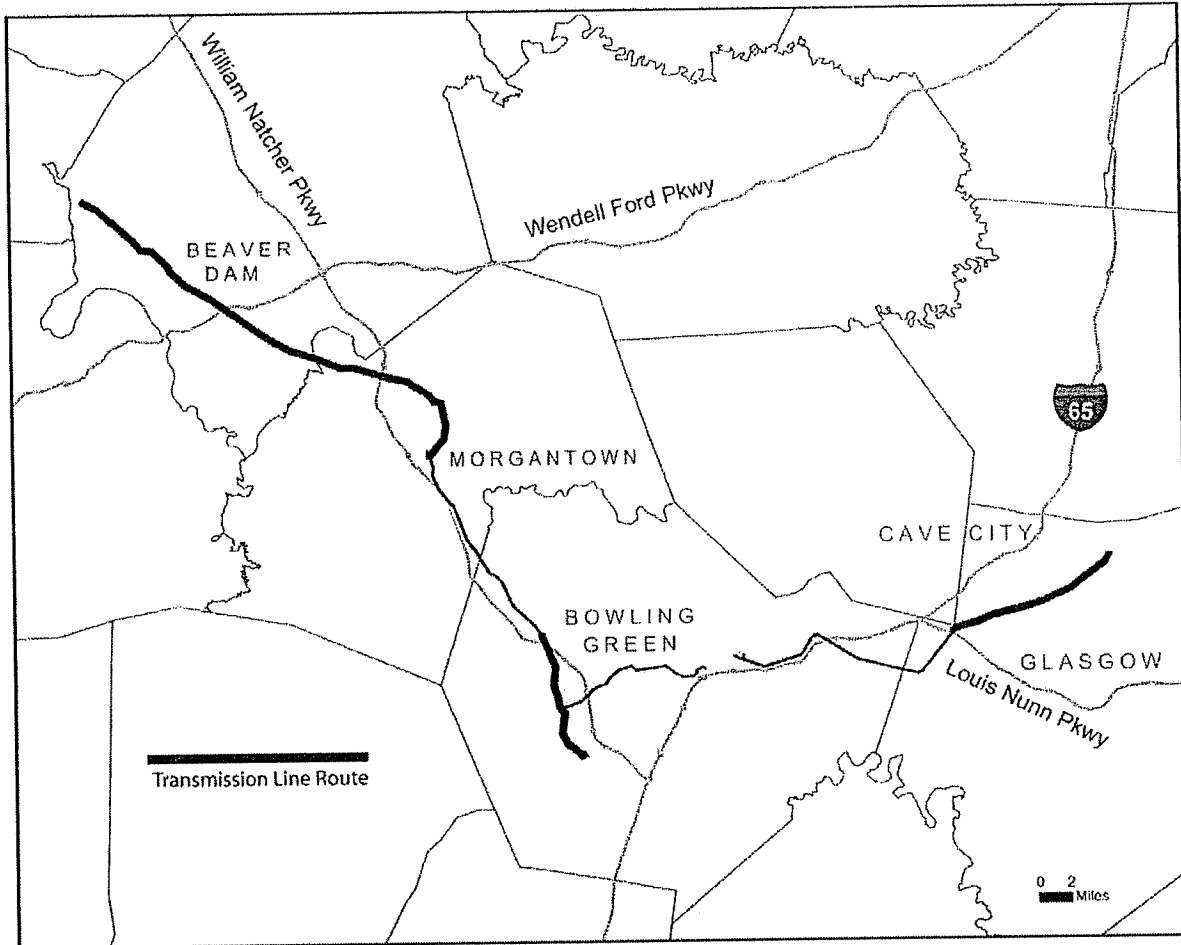

I understand Mr. Cunningham has been in touch with you to discuss the proposed routing of the transmission line on your property. Once our engineers have completed their work, we will provide you with a revised map showing the new proposed route. In addition, we will be filing a revised map with the Kentucky Public Service Commission to reflect those changes.

During our phone conversation last week, you asked about the environmental studies that will be required for this project. Because the federal Rural Utilities Service (RUS) provides financing to EKPC, this project must comply with the National Environmental Policy Act (NEPA). Subject: Memphis Junction to Natcher Parkway Transmission Project

As you are aware, East Kentucky Power Cooperative, Inc., (EKPC) proposes to construct an electric transmission line in your area. It appears a portion of this line will cross your property. This is the same transmission line that was the subject of the Open House on May 10, 2005. You may have been contacted by EKPC representatives for acquisition of an Option to Purchase for the necessary right-of-way.

The proposed project will consist of several segments of new 161-kV transmission lines and rebuilds of existing lines, totaling approximately 90 miles in length, from EKPC's Barren Substation to Big Rivers Electric Corp.'s D.B. Wilson Plant in Ohio County. A map of the proposed project corridor is attached. The purpose of this project is to extend EKPC's transmission system into the Warren Rural Electric Cooperative Corp. (WRECC) service area in order to allow EKPC to provide electric service to WRECC when it becomes a member of EKPC in 2008. Construction will primarily consist of one- and two-pole steel structures, with three-pole steel structures needed for some angles and dead-ends.

The transmission line will require a certificate of public convenience and necessity to be issued by the Kentucky Public Service Commission (PSC). This process will proceed on PSC Docket 2005-00207. You have the right to intervene in these proceedings should you desire and to request a local public hearing. Should you have any questions concerning this process, the Executive Director of the Commission is Elizabeth O'Donnell, Kentucky Public Service Commission, P. O. Box 615, 211 Sower Boulevard, Frankfort, Kentucky 40602-0615, telephone (502) 564-3940.

WALLAGE LOOP

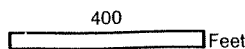

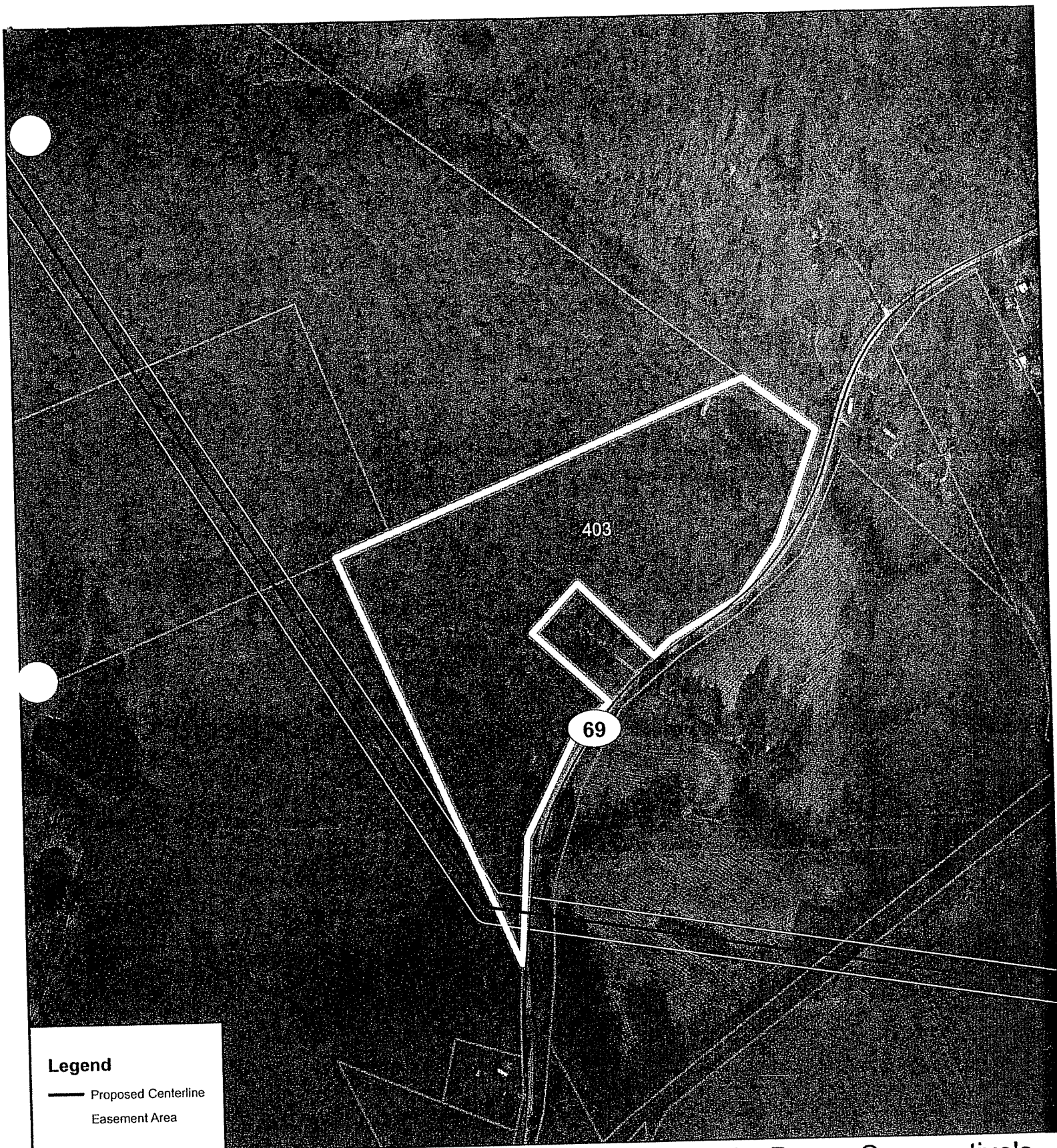

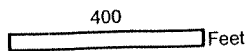

RESPONSIBLE PARTY: Mary Jane Warner

REQUEST: Please identify all existing rights-of-way and transmission lines within the proposed macro-corridor. As to each of the four proposed transmission line segments, identify which rights-of-way and transmission lines are proposed to be used for the project. Identify which rights-of-way and transmission lines are not proposed to be used for the project, and explain why not.

RESPONSE: Exhibits 9-1, 9-2, and 9-3 are maps showing the location and identification of existing road rights of way and existing transmission lines for Barren County – Oakland – Magna, Memphis Jct. – Natcher Parkway Jct., and Wilson – Aberdeen respectively. Roads and other Linear Infrastructure are considered in the EPRI-GTC Methodology as part of the Engineering Perspective and consequently are considered in the comprehensive review of the Study Area for development of Alternative Corridors. Secondary rights of way (small gas lines, water lines, telephone/cable/electrical distribution lines, etc) are not generally suitable for co-location/rebuild for an electric transmission line. EKPC designers specifically considered the existing Linear Infrastructure in the Alternative Corridors when developing Alternative Routes. The

statistical comparison of the Alternative Routes and their respective selection/rejection is discussed in EKPC's response to Carroll & Doris Tichenor's First Data Request, ITEM 1, Exhibit 1-2.

Barren County – Oakland - Magna

The following existing lines or segments thereof are located inside the Barren County to Oakland Macro Corridor. See Exhibit 9-1.

1. EKPC 69kV Goodnight – Munfordville
2. EKPC 69kV Cave City Tap
3. WRECC 69kV Park City Tap
4. WRECC 69kV Oakland to Park City Tap
5. WRECC 69kV Oakland – East Bowling Green
6. TVA 161kV Bowling Green - Summershade

No alternative route was evaluated along the path following lines 1, 2, and 3 because of the nature of line 2. Line 2, the Cave City Tap, is a radial feed that traverses an urban setting. Paralleling was not an option because of the urbanization (the concentration of development including homes, businesses, permanent structures, signs, etc.) around the line. This situation could require the taking of homes and businesses. Rebuilding was not an option because of the lack of a back feed to the Cave City Substation causing the line to be out of service during construction. This path also would have included a new line between Cave City Substation and Park City Substation that would have also been through urban areas.

The proposed plan will rebuild Line 3 and 4 between the new line section and Oakland Substation. This line is also a radial feed, but will be back fed by distribution while the line is being rebuilt.

The proposed plan will also rebuild Line 4 and parallel Line 5 between Oakland and Magna.

Memphis JCT – Natcher Parkway JCT

The following existing lines or segments thereof are located inside the Memphis JCT – Natcher Parkway JCT Macro Corridor. See Exhibit 9-2.

1. WRECC 69kV Bowling Green – Memphis JCT / TVA 161kV Bowling Green - Franklin
2. WRECC 69kV Bowling Green – Auburn
3. WRECC 69kV West Bowling Green Tap
4. TVA 161kV Bowling Green - Lewisburg
5. TVA 161kV Bowling Green - Paradise
6. WRECC 69kV Bowling Green – Morgantown

Lines 2 and 5 were not in the Alternative Corridors selected by the EPRI – GTC Methodology. Therefore, they were not considered as Alternate Routes.

Co-location with Line 1 and 4 was evaluated as part of Route I, along with the rebuild of Line 6.

Co-location with Line 3 was evaluated as part of Routes B, D, and F.

Wilson - Aberdeen

The following existing lines or segments thereof are located inside the Wilson - Aberdeen Macro Corridor. See Exhibit 9-3.

1. Sections 1A thru 1E, WRECC 69kV Morgantown - Purdue
2. WRECC 69kV South Morgantown - Morgantown
3. KU 138kV Ohio County - Schrewsburg
4. KU 69kV Ohio County - Millwood
5. BREC 161kV Paradise – New Hardinsburg
6. KU 138kV/138kV and KU 69kV
7. KU 69kV Ohio County – Beaver Dam
8. KU 69kV Ohio County – Riverview
9. KU 69kV Simmons - Riverview
10. KU 69kV Simmons – Willow Creek
11. KU 69kV/69kV Ohio County - Matanzas
12. KU 138kV Wilson - Matanzas
13. KU 69kV Riverview – Beaver Dam
14. KU 69kV Beaver Dam - Hartford
15. KU 69kv Matanzas - Beda

Lines 2, 4, 5, 7, 8, 9, 13, 14, and 15 were not in the Alternative Corridors selected by the EPRI – GTC Methodology. Therefore, they were not considered as Alternate Routes.

No route was evaluated for co-location along Line 1A because of urbanization around and under the existing line.

Lines 1B, 11, and 12 were evaluated for co-location within Route C.

No route was evaluated for co-location along Line 1C because of urbanization around and under the existing line.

Lines 1D, 3, 6, 11, and 12 were evaluated for co-location within Route F.

No route was evaluated for co-location along Line 1E because of urbanization around and under the existing line and the numerous large angles that the line turns.

No route was evaluated for co-location along Line 10 because of urbanization at the KY 1245 road crossing and the wetlands around the line.
