## EXPLANATION OF BANKRUPTCY DISCHARGE IN A CHAPTER 7 CASE

This court order grants a discharge to the person named as the debtor. It is not a dismissal of the case and it does not determine how much money, if any, the trustee will pay to creditors.

### **Collection of Discharged Debts Prohibited**

The discharge prohibits any attempt to collect from the debtor a debt that has been discharged. For example, a creditor is not permitted to contact a debtor by mail, phone, or otherwise, to file or continue a lawsuit, to attach wages or other property, or to take any other action to collect a discharged debt from the debtor. *[In a case involving community property:]* [There are also special rules that protect certain community property owned by the debtor's spouse, even if that spouse did not file a bankruptcy case.] A creditor who violates this order can be required to pay damages and attorney's fees to the debtor.

However, a creditor may have the right to enforce a valid lien, such as a mortgage or security interest, against the debtor's property after the bankruptcy, if that lien was not avoided or eliminated in the bankruptcy case. Also, a debtor may voluntarily pay any debt that has been discharged.

### **Debts That are Discharged**

The chapter 7 discharge order eliminates a debtor's legal obligation to pay a debt that is discharged. Most, but not all, types of debts are discharged if the debt existed on the date the bankruptcy case was filed. (If this case was begun under a different chapter of the Bankruptcy Code and converted to chapter 7, the discharge applies to debts owed when the bankruptcy case was converted.)

### **Debts that are Not Discharged.**

Some of the common types of debts which are not discharged in a chapter 7 bankruptcy case are:

- a. Debts for most taxes;
- b. Debts that are in the nature of alimony, maintenance, or support;
- c. Debts for most student loans;
- d. Debts for most fines, penalties, forfeitures, or criminal restitution obligations;
- e. Debts for personal injuries or death caused by the debtor's operation of a motor vehicle while intoxicated;
- f. Some debts which were not properly listed by the debtor;
- g. Debts that the bankruptcy court specifically has decided or will decide in this bankruptcy case are not discharged;
- h. Debts for which the debtor has given up the discharge protections by signing a reaffirmation agreement in compliance with the Bankruptcy Code requirements for reaffirmation of debts.

**This information is only a general summary of the bankruptcy discharge. There are exceptions to these general rules. Because the law is complicated, you may want to consult an attorney to determine the exact effect of the discharge in this case.**

RENEWED MOTION TO DISMISS

Comes the interim trustee, Julie Brown Apperson, by counsel, and pursuant to 11 U.S.C. §§ 521(3) and (4) and 707(a) renews the previously filed motion to dismiss the Debtor's case. In support of the motion the Trustee submits the following:

1) The Debtor's *pro se* voluntary petition for relief under Title 11 U.S.C. Chapter 7 was filed November 24, 2004. The petition and schedules indicate the Debtor is retired and receives approximately \$7,000.00 in retirement income a year. Schedule B lists \$350.00 in assets, clothing and furniture, and Schedule F shows \$5,521.76 in unsecured debt – largely comprised of utility debts to Bell South; Insight Cable/AT&T; Louisville Water Company and L, G & E. The other schedules list "0" or has "none" checked. The schedules appear to have had white out applied over a typewritten schedule and hand notations entered to provide this information

2) On December 8, 2004 the interim trustee was contacted by Bellsouth and informed that the Debtor's granddaughter, Patricia (*nee* Story) Conner, appeared to be attempting to use the Debtor's identity to re-establish and/or maintain phone services that had been cut off for lack of payment. BellSouth advised an individual identifying herself as Anna Story contacted BellSouth November 24, 2004 and gave notice she had filed bankruptcy under this case number directing that

service therefore be reconnected. BellSouth's records indicate the *pro se* Debtor's SSN and that of the subscriber to the phone number in question did not match and service was re-terminated.

3) The interim trustee was contacted on December 16, 2004 by an individual identifying herself as Patricia Conner who indicated she is the *pro se* Debtor's granddaughter, had prepared the petition and schedules, that the Debtor suffered from Alzheimer's disease and had no bank accounts and does not file tax returns. The Trustee requested copies of the money orders or documentation from creditors verifying the expenses listed.

4) The interim trustee placed both Patricia Conner and the Debtor under oath at the meeting of creditors January 12, 2005, verified the SSN of Patricia Conner (which matches the subscriber SSN on the BellSouth account) and the Debtor and inquired as to the authority under which Patricia Conner executed the *pro se* petition and schedules on the Debtor's behalf. Patricia Conner testified she was granted power of attorney for the Debtor's financial affairs. The interim trustee passed the Section 341 meeting to be rescheduled pending Patricia Conner providing documentation of her power of attorney over the *pro se* Debtor's affairs. At hearings held March 1 and April 26, 2005 on the previously filed motion to dismiss, the Court directed the U.S. Trustee to conduct an investigation into several related cases involving Patricia Conner and to file a status report with the Court by June 27, 2005.

5) The U.S. Trustee's Report indicates the debtor did not appear at the scheduled Rule 2004 examination and the investigation is ongoing but that this case may be closed from the U.S. Trustee's perspective. The panel trustee submits the foregoing circumstances demonstrate substantial prejudice to interests of unsecured creditors pursuant to Section 707(a) and requests the Court enter the attached Order dismissing the petition with prejudice for six (6) months pursuant to Section 109(g).



**WHEREFORE**, based on the foregoing, the interim trustee requests the Court enter the attached Order dismissing the petition 11 U.S.C. Sections 707(a) and 109(g).


ORDER DISMISSING CASE
