The Sandy Hook Water District (the "District"), by counsel, moves the Commission for leave to withdraw the application in this case on the grounds that pursuant to Part 1 F.20(3) of House Bill 267, a certificate of public convenience and necessity is not required because the District is a Class A or B utility as defined in the Uniform System of Accounts established by the Commission and (1) the District will not, as a result of the waterworks improvement project, incur obligations requiring Commission approval pursuant to KRS 278.300 and (2) the District shall not, as a result of the waterworks improvement project, increase rates to its customers.

For assurance that a Certificate of Public Convenience and Necessity is not required for the waterworks improvement project, the District requests that the Commission make a finding in its order that a Certificate of Public Convenience and Necessity is not required for the subject waterworks improvement project.

WHEREFORE, the Applicant, Sandy Hook Water District, by counsel, moves the Commission for leave to withdraw the subject Application, thereby closing this case; to make a finding in its Order that a Certificate of Public Convenience and Necessity is not required for the subject waterworks improvement project; and to afford the District any and all proper relief.
