MOTION FOR PRE-HEARING CONFERENCE

Comes now Walter Callihan and Goldie Callihan, referred to here and after as Walter and Goldie, and hereby move this Commission for a Pre-Hearing Conference to determine the issues that the KPSC will be entertaining as set out herein as follows below:

Plaintiffs hereby state that restitution in full to the penny that Grayson Rural Electric Cooperative Corporation, referred to herein and after as GRECC, alleged was owed to them by the Plaintiffs was made by offer to GRECC. GRECC refused to accept the money but added other conditions onto the bill they alleged was owed. The extra conditions were that Walter would not write any more Letters to the Editor and would not hold any more public meetings trying to sell and liquidate GRECC, and also that Walter would not go the Kentucky

Public Service Commission, herein and after referred to as the KPSC, with any further Complaints against GRECC, and that Walter would also honor and abide by <u>any</u> rules that the Board of Directors of GRECC set for him to abide by.

After GRECC submitted the information in part that the KPSC ordered them to answer, it is now apparent from the interrogatories that GRECC submitted to the KPSC that the KPSC as well as GRECC are on an uncharted course of procedure that confuses GRECC and the KPSC.

Assuming that GRECC was 100% right alleging that Walter owed \$707.26..... that is now moot. When GRECC refused the payment in full the bill became absolutely moot.

There are only two issues that should be litigated before the KPSC. One iswas full payment offered.....and was security of future payments offered? And second,... can GRECC add extra conditions onto the bill that are not in their tariffs? These are the only two issues that this KPSC should be entertaining. All other issues are moot as far as the administrative remedy is concerned and all damages should and will be heard before a Court of Law and Equity after the KPSC has exhausted the administrative remedy.

There are only two issues before this Commission. Should GRECC have accepted the payment of alleged bill in full and can GRECC add extra conditions onto the bill. Those are the only two issues before this Commission at this time.

Walter and Goldie further move this Commission to compel GRECC unconditionally and order them to restore the electrical power forthwith on December 1st, 2005.

If in fact the hearing officer has full jurisdiction of the hearing and the issues before it, then that hearing officer in fact is the judge and he or she can set the ground rules and determine what is relevant and what is not relevant.
