





Walter and Goldie make their motion for the KPSC with all of it's members and with all of it's legal staff to recuse them from any further participation in the above styled case because there is now pending a Federal lawsuit against same by Walter and Goldie in the U.S. District Court in Ashland, Kentucky for creating a monopoly between the KPSC and Grayson Rural Electric Cooperative Corporation, referred to herein and after as the GRECC, under the Sherman Antitrust Act and the Clayton Act.

Walter makes the following Affidavit as follows:

He states that in a telephone conversation with Mr. Gerald Wuetcher, Chief Counsel with the KPSC, approximately ten days ago from this date, Gerald Wuetcher was hostile toward Walter and stated: "...that if Walter made any more phone calls to the Kentucky Governor's Offices or to any other person including Mr. Wuetcher that Mr. Wuetcher and the GRECC would get together and would prevent Goldie and Walter from getting electricity for many years to come." Walter would agree to take a polygraph test on same. And further this affiant saith not.


For all the reasons stated above, Walter and Goldie move that their request be granted.




