**MOTION OF
THOROUGHBRED GENERATING COMPANY, LLC
FOR FULL INTERVENTION**

Thoroughbred Generating Company, LLC (“Thoroughbred”), through counsel, hereby Moves the Commission, pursuant to 807 KAR 5:001 Section3(8) and the Commission’s August 24, 2005 Order, for Full Intervention in the *Application Of Big Rivers Electric Corporation For Approval Of Electrical Interconnection Service To Thoroughbred Generating Company, LLC*, Case No. 2005-00300. The grounds in support of Thoroughbred’s Motion are set forth below.

1. As a signatory to the Interconnection and Operating Agreement (the “Agreement”), Thoroughbred has a unique interest in this proceeding. Thoroughbred seeks to participate in this matter in order to protect its interest in the Commission’s consideration of the Agreement between Big Rivers Electric Corporation (“BREC”) and Thoroughbred.
2. Thoroughbred’s participation in this matter will not prejudice the rights of any party.

3. Although Thoroughbred's interests are similar to those of BREC in that each party advocates the approval of the Agreement, Thoroughbred's participation in this proceeding may be of some assistance to the Commission.

4. Thoroughbred endorses the Commission's approval of the Agreement and requests that the Commission approve it as soon as practical. Thoroughbred is willing to assist the Commission as appropriate, although there should be little, if any, additional information needed for approval of the Agreement.




