ORDER

On July 18, 2005, Hendron Water District ("Hendron") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Hendron purchases water from Paducah Water Works ("Paducah").

2. Paducah notified Hendron that, effective July 1, 2005, Paducah's wholesale water rate to Hendron would increase from \$1.45 per 1,000 gallons to \$1.50 per 1,000 gallons.

3. During the 12 months ending June 30, 2005, Hendron purchased 189,542,000 gallons of water from Paducah and sold 171,069,800 gallons. The increase in the cost of purchased water is \$9,337, resulting in a purchased water adjustment of \$0.06 per 1,000 gallons.

4. The purchased water adjustment of \$0.06 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The purchased water adjustment of \$0.06 per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after August 1, 2005.

2. The proposed tariff sheets filed by Hendron are accepted as filed.
