This letter is in response to your letter dated August 19, 2005 concerning the referenced Project. I left a telephone message for James Rice this afternoon concerning this matter, but I have not yet had a return call.

In your letter you state that our application remains deficient. I have discussed this matter extensively with Wood Creek Water District personnel. We are completely blank as to what you are looking for.

Per **807 KAR 5:001: Section 9(2)(b)**: We have previously submitted copies of franchises or permits that we are aware of from any public authority for the proposed new construction or extension. The only known exception is approval from the Kentucky Division of Water. As stated in previous correspondence, plans for the proposed project were submitted to the Facilities Construction Branch of the Kentucky Division of Water on April 12, 2005 and are pending approval. A copy of the proposed permit will be submitted to the Kentucky Public Service Commission as soon as it is received.

Per **807 KAR 5:001: Section 9(2)(c)**: We have previously submitted a full description of the proposed location, route, or routes of the new construction or extension. We have also previously submitted a description of the manner in which same will be constructed. And we have also previously submitted that there are no known public utilities, corporations, or persons with whom the proposed new construction or extension is likely to compete.

We are at a complete loss as to what additional information that is necessary to be considered a "non-deficient" submittal. We would greatly appreciate your guidance in helping us provide the information which you need. Please provide a listing of the specific items which are deficient, and we will provide them to you as quickly as possible.

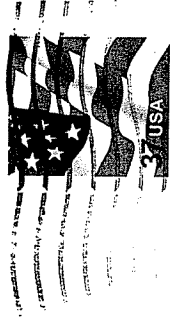
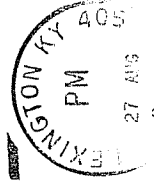
