O R D E R

On January 25, 2006, Water Service Corporation of Kentucky ("Water Service") moved for an extension of time up to and including February 7, 2006 to respond to the Commission Staff's Second Information Request and the Attorney General's Initial Data Request. Water Service states that the extension is necessary due to limited staff and the volume of information requested.

Water Service also moved for the return of certain confidential material set forth in its Application and response to Commission Staff's First Information Request. In support of this motion, Water Service states that it has submitted a revised version of this material that comports with the Commission's finding of confidentiality.

Finding good cause to grant these motions, the Commission HEREBY ORDERS that:


1. Water Service's Motion for Extension of Time and Return of Confidential Materials is granted.

Water Service may file with the Commission the testimony of its rebuttal witnesses in written verified form no later than 04/25/06

Public Hearing is to begin at 9:00 a.m., Eastern Standard Time, in Hearing Room 1 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky, for the purpose of cross-examination of witnesses of Water Service and Intervenors (To be scheduled)
