**RESPONSE:**

The data request states that the witness R.J. Henkes for the Attorney General has proposed to eliminate all expenses Kentucky Power incurs for public and community relations. In reviewing Mr. Henkes' testimony, that does not appear to be what he is saying. His testimony in case 2005-00341 on page 52, lines 2-5, states that the company should assign those costs to the stockholders rather than the ratepayers. While KACA certainly appreciates good corporate citizens such as Kentucky Power which are actively involved in their community, the question of where those costs should be assigned is a decision to be made by the Public Service Commission. I do not know whether those costs are typically assigned to stockholders or ratepayers in other utility cases that have come before the Commission.
