Please describe fully each and every way in which Kentucky Power has made its pole attachment calculations in this case differently from how the Company made its pole attachment calculations in Case No. 91-066. For each difference in the manner of calculation, explain fully why the Company changed its method of calculation.

30. Did KCTA maintain continuing property records of its poles by category of pole height in 1990?

31. If the answer to KCTA Data Request No. 30 is anything other than affirmative, please explain how Kentucky Power determined the number of and investment in poles of different heights in Page 4 of Kentucky Power Exhibit EKW-8 in Case No. 91-066.

32. Did the Company provide in response to KCTA's Data Request No. 10 all of its continuing property records for Account 364?

33. If the answer to KCTA's Second Data Request No. 32 is anything but "Yes," please provide all additional records.

34. If the Company had records in 1990 that reflected the number of and investment in wooden poles of the various sizes and no longer maintains

records of that data, explain fully when the Company ceased maintaining those records, and the reason the Company ceased maintaining the records.

35. Has the Kentucky Commission ever authorized the Company to cease maintaining records of the number of and investment in wooden poles of various sizes? If so, provide a copy of any order on which the Company relies.

36. Provide all continuing property records by year since 1990 reflecting the number of and/or investment in wooden poles of different sizes, for each such year the records were maintained.
