When applicable, the information requested herein should be provided for total company operations and jurisdictional operations, separately.

1. Refer to the response to the Commission Staff's Third Data Request dated December 12, 2005, Item 39. Kentucky Power was asked if it was proposing that the environmental surcharge billed to customers should be determined by the formula "CRR - MEBC" rather than the current approach of "CRR – BRR." Kentucky Power responded by saying this was its initial proposal, but upon reflection it "believes it is appropriate to continue with the current approach of CRR-BRR once the BRR is updated to reflect the base period revenue requirement for the test year in this case." In light of this response, provide Kentucky Power's current proposed adjustment concerning its environmental surcharge. Include all workpapers, calculations, assumptions, and other supporting documentation used to determine the proposed adjustment.
