On April 4, 2006, the Commission issued an Order in this matter approving revised demand-side management tariff riders for The Union Light, Heat and Power Company. The first sentence of the second paragraph on page 3 of the Order included an incorrect amount for the tariff rider for residential electric customers. Two digits were transposed resulting in the rider stated as \$0.00180 per kWh when it should have been \$0.00108 per kWh. In all other respects, the April 4, 2006 Order is correct.
