As you may know Kentucky Utilities presently has pending before the Public Service Commission, Case No. 2005- 000405. This case is a request for the PSC to approve Kentucky Utilities' sale of assets of the Lock 7 hydroelectric plant to an organization named Lock 7 Hydro Partners, LLC.
