MOTION OF EAST KENTUCKY POWER COOPERATIVE, INC., FOR AN ENLARGEMEMENT OF TIME IN WHICH TO FILE RESPONSES TO STAFF DATA REQUESTS DATED DECEMBER 22, 2005

East Kentucky Power Cooperative, Inc., ("EKPC") hereby moves the Kentucky Public Service Commission (the "Commission") for an enlargement of time in which to respond to data requests made by the Commission staff dated December 22, 2005. As grounds for this Motion, EKPC states as follows:

- 1. EKPC did not become aware of the subject data requests until a copy was received in the mail on December 28, 2005. Several key EKPC staff members who must prepare responses to the requests were out of the office at that time on personal leave during the holidays, and did not return to work until January 3, 2006. Due to these absences, it is unlikely that the subject responses can be adequately prepared, reviewed and filed by the due date of January 5.
- 2. EKPC will submit the responses as soon as possible, but requests that the due date be extended for one week so that the responses can be properly completed.

WHEREFORE, EKPC respectfully moves the Commission for an enlargement of time through January 12, 2005, in which to respond to the subject data requests.
