JOINT MOTION REQUESTING MODIFICATION OF SCHEDULING ORDER

dPi Teleconnect, LLC ("dPi") and BellSouth Telecommunications, Inc., d/b/a AT&T Kentucky ("AT&T Kentucky") have agreed, if acceptable to the Kentucky Public Service Commission ("Commission"), to submit this case to the Commission on briefs rather than through a hearing. Accordingly, the Parties request that the Commission modify its August 25, 2009 Order as follows:

The hearing scheduled for February 10-11, 2010, is cancelled. In lieu of a hearing, the Parties shall submit simultaneous briefs by March 19, 2010.
