COMMISSION STAFF'S INTERROGATORIES AND REQUESTS
FOR PRODUCTION OF DOCUMENTS TO FLEMING COUNTY
JUDGE/EXECUTIVE LARRY H. FOXWORTHY

Pursuant to Administrative Regulation 807 KAR 5:001, Commission Staff requests that Fleming County Judge/Executive Larry H. Foxworthy file the original and 8 copies of the following information with the Commission within 20 days of this Order, with a copy to all parties of record. Each copy of the information requested shall be placed in a bound volume with each item tabbed. When a number of sheets are required for an item, each sheet should be appropriately indexed, for example, Item 1(a), Sheet 2 of 6. Careful attention shall be given to copied material to ensure its legibility.

1. State the date when the position on the Western Fleming County Water District ("Western Fleming District") Board of Commissioners became vacant.
2. State the reason for the vacancy.
3. State Mr. Larry Ingram's current address.
4. State whether Mr. Ingram resides in Western Fleming District's territory.

5. Provide a map of Western Fleming District's territory and the ordinances of the Fleming County Fiscal Court and the orders of Fleming County Judge/Executive that established these territorial boundaries.

6. Provide Western Fleming District's by-laws.

7. Describe Mr. Ingram's experience in operating or managing a water utility.

8. Describe Mr. Ingram's experience managing or operating organizations similar to a water utility.

9. State the date on which the term for which an appointment is sought will expire.

10. For each member of Western Fleming District's Board of Commissioners, state his or her name and the date on which his or her term will expire.

11. Provide the minutes of the Fleming County Fiscal Court meeting in which Mr. Ingram's appointment was considered.

12. Provide all written, audio or video transcripts of the the Fleming County Fiscal Court meeting in which Mr. Ingram's appointment was considered.
