In keeping with the Commission's directive on discovery matters in Case No. 2005-00207, I am writing to advise you that my clients will be objecting to your recently-issued data request no. 14 in the above-referenced proceedings. The Companies do not have the requested data, and to the extent that the request seeks to have the Companies do original work to create this data, we object on grounds that the request is unduly burdensome, beyond the scope of permissible discovery, and seeks a study based on factors and weights which were announced to be preliminary in nature and which have not been tested or validated.

While certain of your other requests will also be the subject of objection by the Companies, we intend at this time to provide responses to those requests, including the production of any documents not protected by attorney-client privilege or the work-product doctrine, subject to our objections.

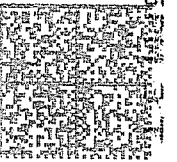
