

NOTICE AND MOTION FOR CORRECTED FINDING
OF ADMINISTRATIVE COMPLETENESS

Louisville Gas and Electric Company ("LG&E") and Kentucky Utilities Company ("KU") (collectively the "Companies") hereby notify the Kentucky Public Service Commission ("Commission") that they have received information that the properties of additional landowners, not previously notified of these consolidated proceedings, will or may be impacted by the proposed lines herein, and that they have now given those landowners notice as required by 807 KAR 5:120 § 2(3). In addition, LG&E and KU respectfully move the Commission to issue an Order: (1) accepting the Companies' tendered amendments to their Applications in these proceedings; (2) withdrawing its previous finding that the Companies' Applications are administratively complete and finding that the Companies' Applications, as amended, became

administratively complete as of January 27, 2006; and (3) setting forth a new procedural schedule to be followed in these consolidated proceedings. In support of this Notice and Motion, the Companies state as follows:

1. On December 22, 2005, the Companies filed with the Commission the Joint Applications that initiated these consolidated proceedings. In compliance with 807 KAR 5:120 § 2, the Companies filed two exhibits to their Applications that were then believed to be accurate. Specifically, the Companies filed, as Exhibit 2, what they believed to be accurate maps reflecting the boundaries of all properties crossed by the proposed transmission line right of way. The Companies also filed, as Exhibit 6, what they understood to be a correct verified statement that, according to county property valuation administrator (“PVA”) records, each property owner over whose property the transmission line right-of-way is proposed to cross had been sent the required notice.

2. In the course of the Companies’ communications outreach effort to landowners affected by the proposed transmission facilities, discussions with one of the affected landowners led the Companies to learn that said landowner had previously transferred title to ten acres of a larger tract of land to a family member. The Companies’ search of PVA records prior to filing the Joint Application did not uncover the existence of that separate ten-acre parcel and, therefore, the new owner of that subdivided parcel was not provided written notice by the Companies in advance of their December 22, 2005 Applications, as contemplated in 807 KAR 5:120 § 2(3).

3. In light of that information, the Companies re-examined the PVA records in Jefferson, Bullitt, Meade and Hardin counties to ensure that all other affected property owners had in fact been notified as provided in 807 KAR 5:120 § 2. As part of that process, the Companies identified a number of inconsistencies in certain PVA records which resulted in an

inability to determine whether certain property ownership transfers were reflected in the PVA records. Those inconsistencies then led the Companies, in this instance, to go beyond the requirements of the regulation and research title records in Jefferson, Bullitt, Meade and Hardin counties to determine accurate landowner information. That process, not surprisingly, also revealed certain recent property transfers which had not been reflected in the PVA records at the time the Companies originally provided notice to landowners in December 2005. The Companies also notified certain additional property owners whose properties, as reflected on PVA maps, are located very close to the planned easement, in order to allow for the possibility that the PVA maps may not show all property lines in their exact locations, and to accommodate the possibility that during the surveying process, the Companies might encounter geological or other physical obstacles that would warrant a slight shift in the location of the transmission line which would cause the line to impact their properties.

4. As a result of these additional inquiries, the Companies identified a number of property owners over whose properties the proposed right-of-way will or may cross but who were not notified in accordance with 807 KAR 5:120 § 2 before the Applications in these consolidated proceedings were filed on December 22, 2005.¹ The Companies have now sent notices to each of those landowners, by both hand-delivery and first-class mail to the address listed in county PVA records.² A verification that notice has been provided, as required by 807 KAR 5:120 § 2(3), is contained at the end of this Notice and Motion.

¹ As noted in the immediately preceding paragraph, certain additional landowners whose properties are located very close to the planned right of way were also notified of the proposed project and these consolidated proceedings out of an abundance of caution. That is the reason for the reference to landowners whose property "may" be affected by the proposed line.

² The Companies also sent letters to landowners who did not receive a second map that was intended to be included in notice letters the Companies sent in December 2005, enclosing a copy of that second map. In addition, the Companies sent letters to landowners whose names in the December notice letters were partially inconsistent with PVA records. All of those landowners are reflected on Amended Exhibit 6.

5. Attached hereto are the Companies' tendered amendments to their previously-filed Applications. Specifically, the Companies attach: Amended Exhibit 2, which contains new maps reflecting the boundaries of all properties crossed by the proposed transmission line right of way in paper form, as well as a CD containing a .pdf version of those maps³; Amended Exhibit 5, containing sample copies of the notice letters provided to all landowners in these proceedings, including those landowners identified after the Applications were originally filed⁴; and Amended Exhibit 6, providing an updated list of all landowners who have been sent notice set forth in 807 KAR 5:120 § 2(3), including those landowners identified after the Applications were originally filed. The Companies respectfully request the Commission to accept these amended exhibits for filing and to find that the Companies' Applications, as amended, were administratively complete as of January 27, 2006, the date of this amended filing verifying that affected landowners have been notified in accordance with 807 KAR 5:120 § 2(3). The Companies also request that the Commission withdraw its current procedural schedule and enter a new schedule, reflecting the corrected date on which the amended Applications were administratively complete and revising the dates for all other procedural steps, including the dates for the evidentiary hearing and the Commission's decision in these matters.

6. The Commission has the authority to permit applications before it to be "amended or corrected" in its discretion. 807 KAR 5:001 § 3(5). Here, the Companies in these Applications seek the approval to construct a transmission line for which a need has been

³ That CD also contains certain other information requested by the Commission Staff in its initial Data Requests in this proceeding.

⁴ While the format of those letters varies somewhat depending upon the stage at which the particular landowner at issue was identified, each letter contains the information required by 807 KAR 5:120 § 2(3): (a) notice of the proposed construction; (b) the commission docket number under which the application will be processed and a map showing the proposed route of the line; (c) the address and telephone number of the executive director of the commission; (d) a description of his or her rights to request a local public hearing and to request to intervene in the case; and (e) a description of the project.

identified by the Commission. Permitting an amendment to the Companies' pending Applications will further the interests of administrative efficiency by not wasting resources that would be expended if these Applications were withdrawn and completely re-filed. In addition, because the Companies are also seeking a new procedural schedule to comport with a corrected date on which the Companies' Applications, as amended, became administratively complete, no prejudice will be suffered by any interested party, including those landowners who only recently received official notice of this proceeding.⁵

WHEREFORE, Louisville Gas and Electric Company and Kentucky Utilities Company respectfully request that the Commission issue an Order:

(1) accepting the Companies' tendered amendments to their Applications in these proceedings;


(2) withdrawing its previous finding that the Companies' Applications were administratively complete and finding that the Companies' Applications, as amended, were administratively complete as of January 27, 2006; and

(3) setting forth a new procedural schedule to be followed in these consolidated proceedings.

⁵ The Kentucky State Board on Electric Generation and Transmission Siting recently faced a similar landowner notice issue in Case No. 2005-00152, and remedied the situation by permitting the applicants to amend their application and resetting the procedural schedule based upon the date on which the amended application was deemed administratively complete. See Board Order of July 28, 2005 in Case No. 2005-00152.



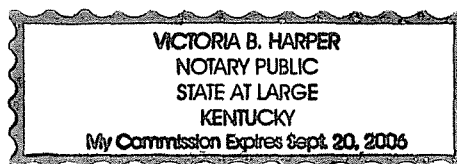



RE: Corrected Notice of Proposed Construction of Electric Transmission Line

Dear [REDACTED]

On December 20, 2005, Kentucky Utilities (KU) wrote to you to explain that we plan on constructing a 345,000 volt electric transmission line from the Mill Creek generating station in Jefferson County to KU's Hardin County substation. In that letter we explained that Part of the planned line may cross your property in [REDACTED] County. However, we only notified you of the alternative route we have proposed and indicated that our preferred route would not cross your property. Since sending the December 20 letter, we have determined that the preferred route would cross a corner of your property if approved. We are sending this letter to correct the inaccurate information in our earlier letter and notify you of the preferred route. A map of the preferred route is enclosed.

KU applied to the Kentucky Public Service Commission for regulatory approval for construction of the preferred line on December 22, 2005. The Commission has assigned the case docket number 2005-00467.

KU also applied to the Commission for regulatory approval of the alternative line described in our December 20 letter on December 22, 2005. The Commission assigned that case docket number 2005-00472. As we explained in our earlier letter, the alternative route is KU's second choice and would only be approved by the Commission if the Commission declines approval of KU's preferred route. Either route would cross your property but would cross in different places.

Under Kentucky law, you and other interested persons have the right to request that the Kentucky Public Service Commission hold a local public hearing regarding the planned line. Please note that other interested parties have already requested a local public hearing and the Commission has scheduled that hearing for 6:00 p.m., Eastern Standard Time, on February 1, 2006, in the Pritchard Community Center, 404 South Mulberry Street in Elizabethtown, Kentucky. You have a right to attend the local public hearing on February 1 and speak at that hearing if you would like to do so. Please note that the hearing date may change. You also have the right to ask to intervene in the case.

While the local public hearing has already been scheduled, we are required to inform you that if you would like make a request for a local public hearing, the request must be made in writing to the Executive Director of the Kentucky Public Service Commission. The Executive Director's address is:

RE: Revised Notice of Proposed Construction of Electric Transmission Line

On December 20, 2005, Kentucky Utilities Company (KU) wrote to you and [REDACTED] with notification of our plans to construct a 345,000 volt electric transmission line from the Mill Creek generating station in Jefferson County to our Hardin County substation. At our meeting in December, you pointed out that the ownership of the properties the planned line would cross had changed. We have verified that the Hardin County PVA records reflect that the properties formerly owned by you and [REDACTED] are now owned by [REDACTED]. Accordingly, we are sending this revised notice to [REDACTED]. Part of the planned line would cross properties of [REDACTED]. The route of the planned line is shown on the map enclosed with this letter.

KU is sending this letter to officially notify [REDACTED] that KU has notified the Kentucky Public Service Commission that we applied for regulatory approval for construction of the planned line on December 22, 2005. The Commission has assigned the case docket number 2005-00467. If the Commission does approve construction of the line, representatives of KU will contact [REDACTED] to discuss purchasing an easement allowing us to build the planned line across a portion of [REDACTED] property.

We have also applied to the Commission for regulatory approval of an alternative line that varies somewhat from the preferred line. If the alternative route is approved, [REDACTED] property will not be affected. However, the alternative route is KU's second choice and therefore would only be approved by the Commission if the Commission declines approval of KU's preferred route.


Any written request for a hearing will need to include the following:

3. a statement as to whether the person requesting the hearing wishes to participate in an evidentiary hearing or to make unsworn public comment.

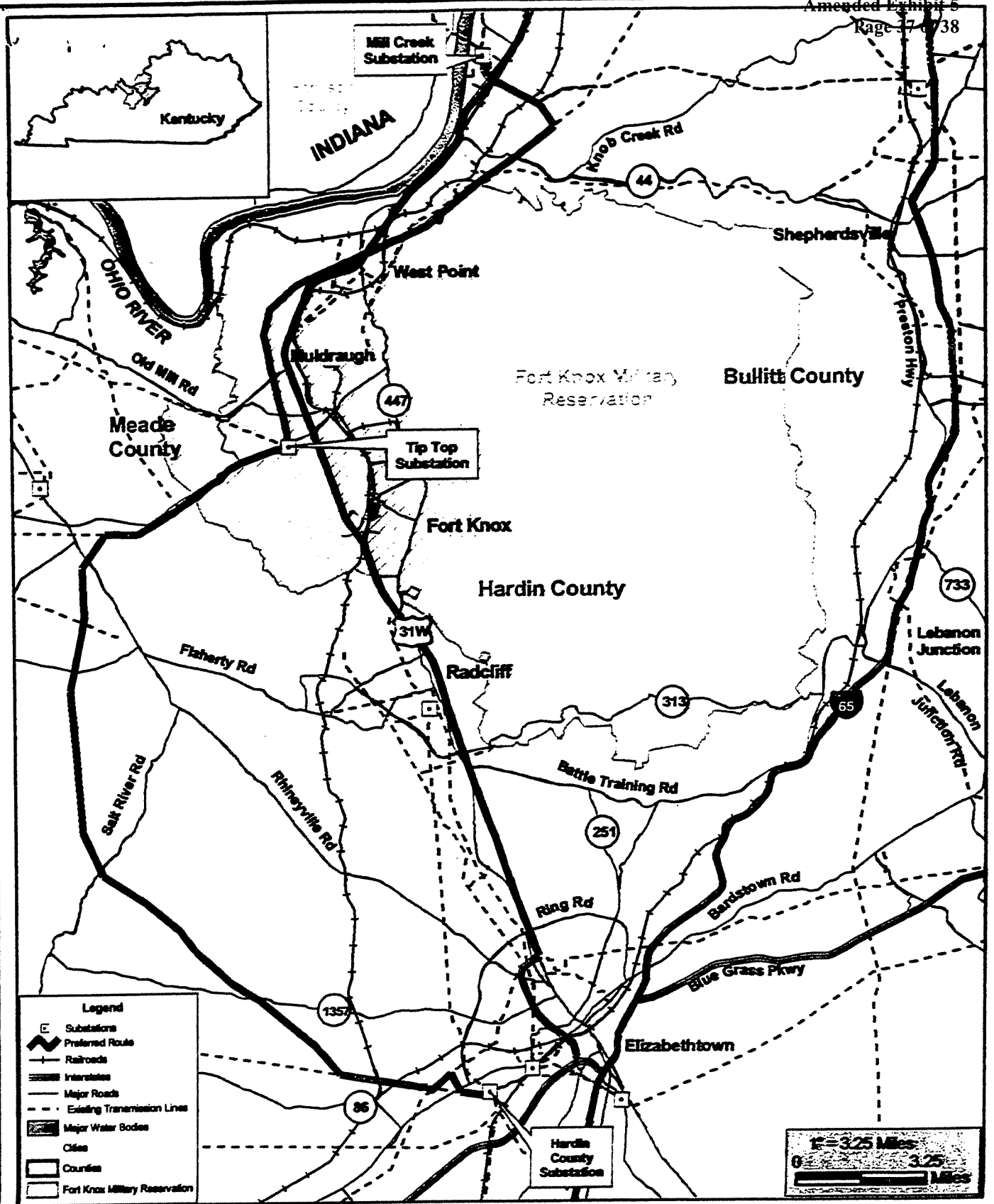

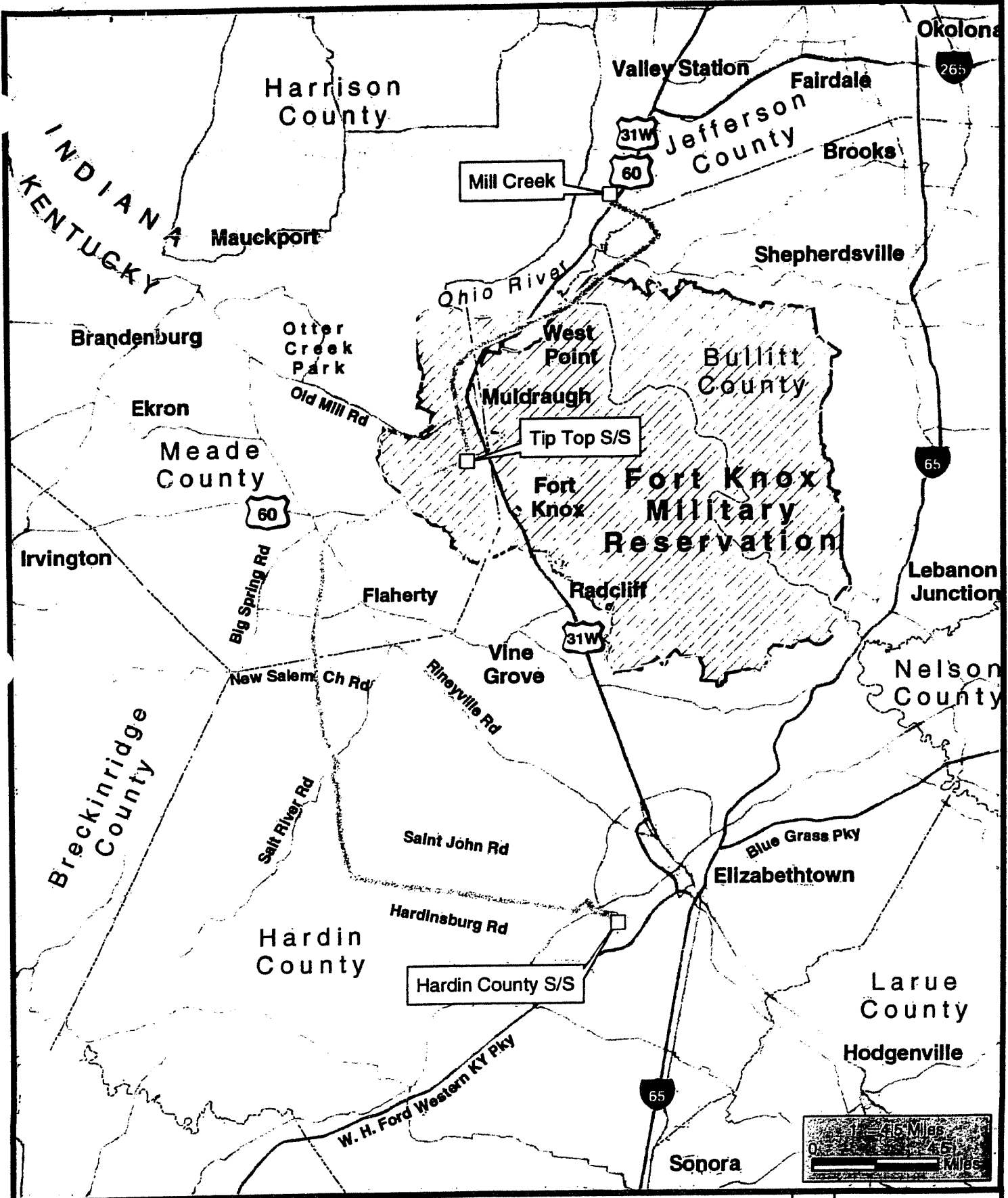
