Dear Ms. O'Donnell:

We have discovered that, as part of the document production made by Louisville Gas and Electric Company ("LG&E") and Kentucky Utilities Company ("KU"), a privileged e-mail was inadvertently produced. Specifically, the Response of LG&E and KU to the Data Requests of Intervenors Dennis and Cathy Cunningham; Harrison and Hardin, dated March 13, 2006, Attachment to Question No. 8, page 131, contained an e-mail exchange (contained on the top half of the page) from in-house counsel to LG&E and KU to his clients and co-counsel on this matter. That exchange is protected by both the attorney-client privilege and the attorney work product doctrine, and was intended to be redacted before production. However, through inadvertent oversight, that redaction was not made before the document was produced in these proceedings.

The purpose of this letter is two-fold. First, we wanted to make you aware of this issue and to advise you and the other parties to this proceeding that the above-referenced disclosure was inadvertent and was not a voluntary or intentional surrender of any privilege or work-product protection. Second, we are requesting that the referenced e-mail be redacted or otherwise removed from all copies of the filing at the Commission (including those available electronically), and that all copies of the e-mail be destroyed. By copy of this letter, we are similarly asking that all parties to this proceeding either return to us, or destroy, all copies of the

referenced e-mail, and that they refrain from disseminating the document at issue to any other person or entity.
