## NOTICE OF INTENT TO SEEK CORRECTED FINDING OF ADMINISTRATIVE COMPLETENESS

Louisville Gas and Electric Company ("LG&E") and Kentucky Utilities Company ("KU") (collectively the "Companies") hereby notify the Kentucky Public Service Commission ("Commission") that they have received information that the properties of additional landowners, not previously notified of these consolidated proceedings, may be impacted by the proposed lines herein, and that they have now given, or are in the process of giving, those landowners notice as required by 807 KAR 5:120 § 2(3). In light of that development, LG&E and KU will file amendments to their Applications and ask that the Commission find that the amended Applications will be administratively complete on the date that the last landowner was notified in accordance with the regulation. The Companies will also move the Commission to amend the procedural schedule in these consolidated proceedings.

Specifically, LG&E and KU intend to file a further pleading within the next 2-3 business days, styled "Notice and Motion for Corrected Finding of Administrative Completeness," further advising the Commission of this issue and attaching amended Application exhibits for filing. In that pleading, the Companies expect to move the Commission to issue an Order: (1) accepting the Companies' tendered amendments to their Applications in these proceedings; (2) amending the date on which the Companies' Applications are to be deemed administratively complete; and (3) setting forth a new procedural schedule to be followed in these consolidated proceedings.

For all of these reasons, LG&E and KU request postponement of the presently-scheduled local public hearing, now set for February 1, 2006, pending Commission receipt of, and ruling on, the Companies' Notice and Motion for Corrected Finding of Administrative Completeness.
