


**MOTION TO DISMISS**

Big Rivers Electric Corporation ("Big Rivers") moves that this case be dismissed. In support of its motion, Big Rivers refers to Ordering Paragraph 7 of the March 6, 2009, Order in *The Applications of Big Rivers Electric Corporation for: (I) Approval of Wholesale Tariff Additions for Big Rivers Electric Corporation, (II) Approval of Transactions, (III) Approval to Issue Evidences of Indebtedness, and (IV) Approval of Amendments to Contracts; and of E.ON U.S., LLC, Western Kentucky Energy Corp., and LG&E Energy Marketing, Inc., for Approval of Transactions*, PSC Case No. 2007-00455, which states that "[w]ithin twenty days of the date of closing the Unwind Transaction, Case No. 2005-00485, which was established to review Big Rivers' 2005 IRP, shall be terminated." The Unwind Transaction closed on July 16, 2009.

WHEREFORE, Big Rivers moves the Commission that this matter be dismissed, and for all other relief to which it may appear entitled.


