When a number of sheets are required for an item, each sheet should be appropriately indexed, for example, Item 1(a), Sheet 2 of 6. Include with each response the name of the witness who will be responsible for responding to questions relating to the information provided. Careful attention should be given to copied material to ensure that it is legible. Where information requested herein has been provided, in the format requested herein, reference may be made to the specific location of said information in responding to this information request. When applicable, the information requested herein should be provided for total company operations and jurisdictional operations, separately.

- 1. Provide a description of the contractual relationship between Nolin and Fort Knox as it relates to the "Demand Side Management and Cost Containment" projects. Include in this description a discussion of what Nolin provides to Fort Knox on these projects and the rights and responsibilities of Nolin and Fort Knox under the contract.
- 2. In Case No. 2003-00079¹ the Commission authorized Nolin to borrow \$35,000,000 from the National Rural Utilities Cooperative Finance Corporation ("CFC") for a 15-year period in conjunction with the Fort Knox contract.
- a. Describe the status of this loan as of the date of the Application in this case.
- b. Prepare a schedule showing the end of the month outstanding balance on this loan for each month in the period May 2003 through November 2005.
 - 3. Concerning the proposed \$24,000,000 term loan:
- a. Explain why Nolin is seeking approval for a \$24,000,000 loan. Include in this explanation the reason(s) why this additional level of indebtedness is needed.

credit?

d. Explain why approval of the \$24,000,000 line of credit was not

included as part of this Application.
