O R D E R

Pursuant to Administrative Regulation 807 KAR 5:056, the Commission, on December 27, 2005, established this case to review and evaluate the operation of the fuel adjustment clause ("FAC") of Kentucky Utilities Company ("KU") for the 6 months ended October 31, 2005.

As part of this review, KU, pursuant to Commission Order, submitted certain information concerning its compliance with Administrative Regulation 807 KAR 5:056, and, on February 23, 2006, filed supplemental information in response to a Commission Staff data request. A public hearing was held on March 16, 2006.

The Commission has previously established KU's base fuel cost at 18.10 mills per kWh.<sup>1</sup> A review of KU's monthly fuel clause filings shows that the actual fuel cost incurred for the 6-month period under review ranged from a low of 19.28 mills in May 2005 to a high of 25.70 mills in August 2005, with a 6-month average of 23.77 mills.


