
This letter is to call the Commission's attention to AT&T Kentucky's pending Motion for Issuance of a Damages Award on an Expedited Basis filed on November 9, 2007, in the above-styled cases. These cases were remanded on September 18, 2007, by the U.S. District Court in *BellSouth Telecommunications, Inc. v. Kentucky Public Service Commission, et al.*, Case No. 3:06-CV-00065-KKC, to the Commission to determine the damages, if any, owed to AT&T Kentucky as a result of the Commission's orders declared by the court to be unlawful and enjoined from enforcement.

The amount of money at issue is significant for both Parties and warrants a close and expeditious review by the Commission, particularly in light of the fact that these cases have been ongoing since 2005. Both Parties have fully briefed the issue of damages, with the last pleading filed two months ago on February 8, 2008, by SouthEast Telephone, Inc. If the Commission believes an oral argument would be beneficial and necessary in reaching an expeditious decision, AT&T Kentucky requests that the argument be scheduled quickly. Otherwise, the case is ripe for decision and AT&T Kentucky would appreciate the Commission issuing its decision in an expedited fashion.
