## **INTERVENORS', CWA AND IBEW, MOTION TO DISMISS**

Come the Intervenors, CWA and IBEW, and move the Commission to dismiss the joint applicants filing, without prejudice.

In support of this motion, Intervenors adopt and advance all of the arguments raised by the Attorney General in his Emergency Motion to Dismiss Joint Applicants Filing of April 19, 2006.

The dramatic shift in financial obligations must have corresponding adjustments to other terms and conditions of the merger. Even if Kentucky regulated entities are exempted from guarantees or liens, the prudence and viability of the merged operations must still be of first concern to this Commission. As urged by the Attorney General, such implications must be subject to the discovery process, and appropriate advocacy from the parties, prior to final consideration by the Commission. The change in financing strategy should not cause the merger to side-step regulatory review by shifting debt obligations to non-regulated forums.
