Pursuant to 807 KAR 5:001, Section 3(8), NuVox Communications, Inc. (“NuVox”) submits this motion for full intervention in the above-captioned proceeding.


NuVox is a utility which interconnects with and is party to an interconnection agreement with Kentucky ALLTEL, Inc. (“ALLTEL”), an applicant in this matter. The application states there are “rapidly changing fundamentals of the wireline business” and that the applicants need to “adapt their existing business models to more effectively compete.” As a competitor to ALLTEL, NuVox has an interest in how the proposed transaction and changes to ALLTEL’s business model may affect ALLTEL’s performance of its contractual and other obligations to competitive carriers.

NuVox’s special interest in this proceeding is not otherwise adequately represented. Participation by NuVox is likely to present issues or to develop facts that will assist the Commission in fully considering this matter without unduly complicating the proceedings.


