O R D E R

On January 4, 2006, Cannonsburg Water District ("Cannonsburg") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068. Cannonsburg was notified on January 10, 2006 that the filing was deficient. On January 18, 2006, Cannonsburg filed information that cured the deficiencies and the application was considered filed.

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Cannonsburg purchases water from the city of Ashland ("Ashland") and Big Sandy Water District.
2. Ashland notified Cannonsburg that, effective January 1, 2006, Ashland's wholesale water rate to Cannonsburg would increase from \$1.20 per 1,000 gallons to \$1.32 per 1,000 gallons.
3. During the 12 months ending September 30, 2005, Cannonsburg purchased 370,911,000 gallons of water from Ashland and sold 291,684,900 gallons. The increase in the cost of purchased water is \$44,509, resulting in a purchased water adjustment of \$0.15 per 1,000 gallons.
4. The purchased water adjustment of \$0.15 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The purchased water adjustment of \$0.15 per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after January 1, 2006.

2. Within 20 days of the date of this Order, Cannonsburg shall file with the Commission revised tariff sheets showing the rates approved herein.

The following rates and charges are prescribed for the customers in the area served by Cannonsburg Water District. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of the Commission prior to the effective date of this Order.

Over	100,000 gallons	3.75 per 1,000 gallons

##### 2" and 3" Meters:

First	20,000 gallons	\$104.10 Minimum Bill

Over	100,000 gallons	3.75 per 1,000 gallons

##### 6" Meter:

First	50,000 gallons	\$239.70 Minimum Bill
