

**MOTION OF FARMDALE DEVELOPMENT CORPORATION FOR INFORMAL  
CONFERENCE**

Comes the Applicant, Farmdale Development Corporation (“Farmdale”), by counsel, and for its Motion for Informal Conference, states as follows:


On January 19, 2006, the above styled Application for Adjustment in Rates (“Application”) was filed on behalf of Farmdale. Included with the Application was a request for a monthly construction surcharge so that badly needed capital improvements could be made to the subject wastewater treatment plant, including capital improvements to the remote lift station. The single remote lift station associated with this Wastewater Treatment Plant was installed over thirty (30) years ago when the Farmdale subdivision was built. The remote lift station is of fiberglass construction and has two pumps. The two pumps in the remote lift station are over ten (10) years old and were in very poor condition at the time the Application was filed.

Since the filing of the Application, the two pumps at the remote lift station have failed. The Applicant has incurred substantial costs in paying for service runs made to this remote lift station. Additionally, one of the pumps had to be substantially reworked by Quality Electric in Louisville at a cost of \$1,600. This pump was reinstalled after this “band aid”, interim repair was completed. However, this pump cannot be relied to continue to operate for an extended period of time. The second pump at the remote lift station is now undergoing repair at Quality Electric. If

this pump can be repaired, it will not be reinstalled in the remote lift station because the guide rails, the guide rail brackets and the discharge piping are in such bad shape. Instead, the second pump will be retained as a “back up” to the first pump. This second pump also should not be relied upon to operate for an extended period of time if it is necessary to place it into service. Furthermore, the entire remote lift station is in extremely bad repair and needs to be replaced as soon as possible.

The Farmdale Development Corporation has obtained a quote to replace the remote lift station and all of the equipment, including the pumps and the internal piping, for a cost of approximately \$30,425.00. Because this work needs to be done as soon as possible, and the process to review the Application for Adjustment in Rates takes at least 6 to 8 months, Farmdale hereby moves the Public Service Commission to schedule an informal conference to discuss the possibility of approving that part of the surcharge applicable to the remote lift station on an expedited basis.


