On January 30, 2006, Magoffin County Water District ("Magoffin District") applied for authority to revise certain non-recurring charges. Magoffin District has provided adequate evidence of the individual expenses incurred to provide the services associated with the proposed charges.

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. The proposed charges are less than the expenses incurred to provide the associated services. However, Magoffin District, being aware that it could have justified a higher charge, has opted to charge the rate proposed in its application.

2. The charges and policies set forth in Appendix A to this Order are fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:


1. The charges in Appendix A are approved for services rendered on and after the date of this Order.
