On July 6, 2006, Shelby Energy Cooperative, Inc. ("Shelby Energy") filed a written response to the Commission's June 8, 2006 Order initiating this proceeding. IT IS THEREFORE ORDERED that:


1. Shelby Energy shall file within 7 days of the date of this Order the Report referenced in its July 6, 2006 response.
