

**JOINT MOTION TO RESCHEDULE HEARING**

Dialog Telecommunications (“Dialog”) and BellSouth Telecommunications, Inc. (“BellSouth”), by counsel, jointly request the Kentucky Public Service Commission (“Commission”) to reschedule the hearing on this matter for September 13, 2006.

The Commission’s June 6, 2006, procedural schedule in this proceeding set this case for hearing on August 23, 2006. The Parties are in negotiations and believe that rescheduling the hearing will give the parties additional time to negotiate and possibly reach settlement on all remaining arbitration issues. For purposes of rescheduling, BellSouth’s witnesses are available on September 13, 2006. As of the filing of this joint motion, Dialog has been unable to determine if all of its witnesses are available on such date.




