JOINT MOTION TO RESCHEDULE HEARING


Dialog Telecommunications (“Dialog”) and BellSouth Telecommunications, Inc. (“BellSouth”)(collectively, the “Parties”), by counsel, jointly request the Kentucky Public Service Commission (“Commission”) to reschedule the hearing on this matter currently set for September 14, 2006.

The Commission’s June 6, 2006, procedural schedule in this proceeding set this case for hearing on August 23, 2006. By Order dated August 22, 2006 the Commission granted a joint request by the parties to postpone the hearing to give the parties time to negotiate and possibly reach settlement. These negotiations have been productive and are continuing, but may not be concluded prior to the scheduled hearing date. Dialog and BellSouth continue to believe that settlement on all remaining arbitration issues is likely and ask that the Commission postpone the September 14 hearing.

In proposing the original procedural schedule on May 22, 2006, the Parties agreed that to the extent necessary they would waive any right they may have to assert the Commission failed to act within the statutory timeframe set forth in 47 U.S.C. § 252. If the Commission grants the motion to postpone the Parties propose to provide a status report to the Commission by September 22, 2006.

For the foregoing reason, the Parties jointly request the Commission to grant their request to reschedule the hearing in this case to a date following September 15, 2006, on which all witnesses are available.
