Dialog Telecommunications ("Dialog") and BellSouth Telecommunications, Inc. ("BellSouth") have jointly requested that the Commission reschedule the September 14, 2006 public hearing. In support of their request, Dialog and BellSouth assert that they believe settlement on all remaining arbitration issues will likely occur. The Commission finds the parties' proposal to be reasonable.

IT IS HEREBY ORDERED that:

1. The September 14, 2006 hearing is canceled, to be rescheduled if necessary.
2. By no later than September 22, 2006, the parties shall provide a written notice of the status of their negotiations, including a projected date for filing their negotiated agreement
