## ORDER

On March 13, 2006, Harry Clinton Fentress ("Complainant") filed with the Commission a formal complaint against AT&T Communications of the South Central States, LLC ("AT&T") alleging that he was charged for an 800 number that he didn't ask for or know he had. By Order dated March 17, 2006, the Commission directed AT&T to satisfy or answer the complaint. On April 3, 2006, AT&T filed its notice of satisfaction with the Commission and stated that on or about March 17, 2006, a refund was issued to the Complainant in the amount of \$101.55 as satisfaction of the complaint.

Pursuant to 807 KAR 5:001, Section 12(5), upon an offer of satisfaction, a complainant's acceptance of the offer, and the Commission's approval, no further proceedings are necessary. It appears from the record that AT&T has satisfied the complaint. As of the date of this Order, the Commission has received nothing from the Complainant to indicate whether he accepts or rejects AT&T's offer of satisfaction.

### IT IS THEREFORE ORDERED that:

- 1. Within 10 days of the date of this Order, Complainant shall file with the Commission notice of his acceptance or rejection of AT&T's offer of satisfaction.
- 2. If no such filing is received, the complaint shall be considered satisfied, and this case shall be closed and removed from the Commission's docket.
