**MOTION FOR EXTENSION OF TIME AND RENEWAL OF MOTION TO
PERMIT DISTRICT TO AMEND ITS TARIFF ON A TEMPORARY BASIS**

Comes, South Anderson Water District, by and through counsel, and hereby moves the Public Service Commission as follows:

1. The District hereby requests an extension of time to and through Friday, June 23, 2006, to respond to the Commission's Staff first data request dated May 10, 2006.

This request is due to the time restraints involved in the Commission's Staff and counsel pulling together the appropriate information needed to respond to this request and at the minimum; an additional thirty days will be required to respond.

The District would like to put the Commission on notice that additional time may be needed for various portions of the data request in that there are twenty some requests with sub-paragraphs under some of the individual data requests.

2. The District hereby renews its request to permit the district to amend its existing tariff on a temporary basis during the pendency of this action to add the following language:


The District may not have funds available to pay back customers, developers as new lines are extended, and customers are connected to the system. The District reserves the right to pay back all refunds to customers and developers over a ten-year period.

The District previously made this Motion on March 31, 2006 in response to a meeting with the Commission's Staff. It was the District's opinion that the Commission's Staff was in favor of such an amendment and was encouraged by the Commission's Staff to file this Motion for such an amendment during the pendency of this action. The District hereby renews said Motion and would request the relief sought on a temporary basis so that the District can amend its tariff during the pendency of this action.

WHEREFORE, South Anderson Water District hereby moves the Public Service Commission for the extension of time requested herein, and for an Order permitting it to amend or modify its existing tariff to add the additional language during the pendency of this action.



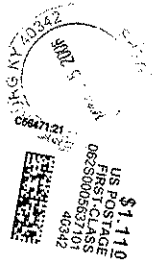
