## MOTION OF PRESTONSBURG TO WITHDRAW ITS MOTION TO INTERVENE

The City of Prestonsburg and the Prestonsburg City's Utilities Commission (collectively "Prestonsburg"), moves the Public Service Commission ("Commission") to approve Prestonsburg's Motion to Withdraw its Motion to Intervene.

This proceeding was initiated by the filing of a Joint Petition for the Transfer of Assets and Debts by the City of Pikeville and Mountain Water District (collectively "Joint Petitioners") on March 21, 2006. Thereafter, Prestonsburg filed its Motion to Intervene. After the filing of various pleadings by the parties, this matter was taken under submission by the Commission. Based on multiple representations contained in various pleadings filed by the Joint Petitioners that the project proposed in the Joint Petition is a separate project from the projects proposed by the Interlocal Agreement dated January 1, 2006, Prestonsburg requests that its Motion to Withdraw Its Motion to Intervene be granted, and further, Prestonsburg reserves its right to file a Motion to

Intervene when Sandy Valley Water District files its Petition to Approve the Transfer of Assets and Related Debt.

WHEREFORE, Prestonsburg moves the Commission for entry of an Order approving Prestonsburg's Motion to Withdraw its Motion to Intervene.
