Dear Ms. O'Donnell:

I am writing to advise the Commission on how Louisville Gas and Electric Company and Kentucky Utilities Company (collectively the "Companies") will comply with its orders of January 31, 2007.

The Companies will recalculate their respective Base Environmental Surcharge Factor ("BESF") using the base revenues for the twelve-month period ending December 31, 2006 pursuant to the Commission's January 31, 2007 orders.

The Companies will file revised tariff sheets with revisions to base rates to reflect the incorporation of the amounts found just and reasonable for the two-year billing period and the supporting calculations and work papers for the determination of BESF with the Commission on or before February 20, 2007. The Companies will propose the new base rates effective for bills rendered on

and after March 5, 2007, which is the start of the second full billing cycle after the Commission's Orders were issued.

Finally, the Companies will file with the Commission their regular monthly surcharge reports and billing factor for March 2007 on or before February 23, 2007 reflecting the findings in these proceedings.
