O R D E R

On June 12, 2006, Kentucky Utilities Company ("KU") and Louisville Gas and Electric Company ("LG&E") moved to extend to June 14, 2006 the time to file responses to the Commission's April 25, 2006 Orders.

In support of their motions for extension, KU and LG&E noted that questions about the accuracy of the responses were raised that needed to be addressed in order to present accurate information in the filing and a correct calculation of the over- or under-recovery. KU and LG&E stated the request for the additional time is necessary to

conduct this review and verification. KU and LG&E requested that the informal conference, currently scheduled for June 20, 2006, still be held on that date.

KU and LG&E served copies of motions on the Office of the Attorney General and the Kentucky Industrial Utility Customers, Inc. No comments have been received from either party concerning the requested change in the response due date.


The Commission has reviewed the motions and finds the requested changes in the procedural schedule are reasonable. The responses to be provided by KU and LG&E need to present accurate information and the correct calculation of any over- or under-recovery. The Commission also believes it is reasonable for the informal conference to be held as currently scheduled on June 20, 2006.

IT IS THEREFORE ORDERED that the requests by KU and LG&E to file their responses to the Commission's April 25, 2006 Orders on June 14, 2006 and their request that the informal conference be held on June 20, 2006 are granted.
