Dear Ms. O'Donnell:

In receipt of your very complicated letter, I will try to answer to the best of my knowkedge, with the limit of 10 days here and 30 days there (your letter dated 8-9-2006, which I received on Sat. 8-12-2006). I don't think 10 days is not enough time to get all my witness testimonys, and all the information you requested, since the other parties have had all this time to get their material together (WHICH I AM REQUESTING ALL COPIES OF ALL MATERIAL YOU HAVE RECEIVED FROM THIS CUMERLAND CELLULAR PARTNERSHIP WHICH IS MANAGED BY BLUEGRASS CELLULAR, INC., WHICH THEY ARE OVER SEEN BY DUO COUNTY COOP TELEPHONE COMPANY, JAMESTOWN, KY, MANAGED BY BILL MCGRUDER, WHICH I HAVE HAD ISSUES WITH HIM BEFORE AND I KNOW THIS IS WHY I DID'NT RECEIVE A COPY OF THE FIRST LETTER WHEN EVERYONE ELSE GOT A LETTER.) I DID NOT RECEIVE A LETTER REGARDING THIS TOWER UNTIL I COMPLAINED ABOUT IT, CALLING IT A DISCRIMINATION, WHICH IT IS. A DISCRIMINATION., SEX DISCRIMINATION, THEY SENT MY BROTHER A LETTER BUT DID NOT SEND ME A LETTER, Who are these partners in this CUMERLAND CELLULAR PARTNERSHIP, I need some names of people in this partnership and their addresses. Because no listing in the phone book for CUMBERLAND CELLULAR PARTNERSHIP. WHO ARE THEY???????

On the big sign, across the fence from my property, it had the address of BLUEGRASS CELLULAR on Ring Road in Elizabethtown, Ky., nothing mentioning this CUMBERLAND CELLULAR PARTNERSHIP. I mailed letters to this address in Elizabethtown, which was returned with note written by hand "they don't live here". What is the current mailing address of this CUMBERLAND CELLULAR PARTNERSHIP, that is mentioned so often in your letter??????

You mentioned in your letter that you wanted Ms. Grider to furnish you with other alternative location or locations to build the 240 ft. cellular microwave tower instead of across the fence about 50 ft. from my property, and approximately 75 ft. from where I am going to build my new house. Ms. O'Donnell, did you know they have or had a BLUEGRASS CELLULAR TOWER ONLY 1/2 mile down the road on Damron Creek Road on the John & Paula Foley property, which John died a few months ago with cancer probably from the radiation of that 240 ft. cellular tower, and now the neighbor that lives across the road within 500 ft. of the tower also has cancer, Joe Wilson. So why don't they put the 240 ft. tower back where it was and get it away from me and my property. And since you give the address of this Cumberland Cellular Tower to be erected at the location of 728 Damron Creek Spur Road, which is the mailing address of Andrew Antle, I suggest you put this tower in his front yard on Damron Creek SPUR Road, not across the fence from my property on Damron Creek Road. These are two different roads. Andrew Antle was trying to put it as far away as possible from his house by putting the tower right across from my property. Please take another look at that map and you will find my property is on Damron Creek Rd., but they are wanting to erect that tower on Damron Creek Road, not Damron Creek Spur Road. (Damron Creek Spur Road is only a mailing address, not the sight of the proposed tower.) Now there is

two alternative locations to build that tower instead of next to my property line. I don't know how many locations you want me to give you. Another good location would be to build this tower in the front yard on Bill McGruder. I'm sure he don't want that 240 ft. tower in his front yard, just like I don't want that 240 ft. tower next to my new house. What do you think a brand new home sitting next to that 240 ft. tower across the fence would be worth????????????? I would like to ask you another question your Honor, do you have a 240 ft. cellular tower in your front yard and would you like to live under this 240 ft. cellular tower????????????? Please take this into consideration upon your judging this application of this 240 ft. tower approximately 50 ft. from the fence line of my property.

Answering your request for Ms. Grider to furnish you with alternative location to build the 240 ft. cellular microwave tower, please find the following list of locations as explained above:

1. 1/2 mile down the road on John & Paula Foley property, across the road from Joe Wilson residence on Damron Creek Road.
2. 728 Damron Creek Spur Road in the front yard of Andrew Antle residence. (his house)
3. Bill McGruder fancy residence, in front yard of his big mansion, perfect place for it.
4. How about putting one in your front yard, before you give it to me. try it out and see how well you like it.
5. Anywhere up in Casey County, they got lots of big hills up there.
6. Put a microwave cellular tower in front of the capitol in Frankfort, if you like them so well.
7. Put one in the front yard of the FCC office in Washington, D.C.
8. I don't care where they put it as long as it is away from me and my family and property. Go aggravate someone else your tower, go cause them enough stress to kill a horse. This mess has caused me to have to go to the doctor and get nerve pills, which I want compensated for. \$75.00 office call, plus the pills \$38.00 equals \$113.00 and I'm suppose to go back in 30 days for check up of the current situation, which will be another \$113.00. *+ \$60 gas*

You mentioned in your letter that CUMBERLAND CELLULAR PARTNERSHIP did not object my intervention hearing because this is how these greedy lawyers get paid, they look for interventions, so they will have to appear and get paid more money. Well, I have a complaint and REQUEST for this issue also. I want compensated for all my inconvenient expenses as follows: Whatever these lawyers are getting paid by hour, plus travel time, gas, lodging at 5 star hotel and if you don't have one in Frankfort, Me and all my witnesses will have to go to Lexington and spend the night before the hearing on Nov. 14 at 9:00 a.m. Eastern Standard Time. Plus all my witnesses want to be paid exactly like the lawyers get paid for by the hour and travel expenses, gas and 5 star hotel lodging. I want paid up-front by CUMBERLAND CELLULAR PARTNERSHIP, FOR ALL THESE EXPENSES I AM GOING TO BE OUT BECAUSE OF THEM WANTING THIS CELLULAR TOWER WITHIN 50 FT OF MY PROPERTY FENCE LINE. My witnesses have to take off from work and come up there with me, and these are professionals, just like the lawyers they have hired, and they have to be compensated just like the lawyers, and request the same amount as the lawyers get. A cheap lawyer gets \$300. an hour plus all the other expenses and that's what my witnesses are requesting. Plus I want compensated for a lawyer to represent me, if I have to hire a lawyer between now and Nov. 14, 2006. I feel they have the money to pay a lawyer to represent them, they can afford to pay for a lawyer of my choice to represent me.

Second, I want them to pay me for all the damage to my property and the decreasing value of the property. Another thing, what about the damage of animals. This Grider farm has been known for over 100 years for its Black Angus Beef Cows, there has been cows back there on the property across the property fence line for over 100 years of where they want to put that microwave cellular tower 240 ft. What about the radiation to beef cows, would you want to eat a big steak from a cow

that had been grazing under this big 240 ft. cellular tower???????????????????? I have plans on putting beef cattle back there next to my new house, in that good hay field. I am waiting for a reply from US Dept. of Agriculture regarding this environmental issue on radiation

You mentioned in your letter that Cumberland is a Kentucky limited liability partnership and should show the proper status. What is the limited liability \$ _____ ?????? You forgot to mention the amount of liability in this issue, therefore I am requesting their liability amount.

Your Honor, I want to thank you in advance for granting me the intervention hearing on the proposed cellular facility scheduled for November 14, 2006 at 9:00 a.m. Eastern Standard Time in the Commission's Office at 211 Sower Blvd. , Frankfort, KY . I will be there , along with my witnesses, therefore I am requesting in writing directions to your office on 211 Sower Blvd., in Frankfort, Ky.

Witnesses as follows:

1. GARY GRIDER, my brother who owns half of the property and is my business partnership, and his testimony is regarding the real estate property value after this 240 ft. tower is erected across the property fence line of approximately 50 ft. Also, the medical liability from this cellular microwave tower. And he also suggest that you take that tower and put it back up 1/2 mile down the road on John & Paula Foley property at the top of Damron Creek Road Hill. What was the purpose of taking the tower down to begin with and causing all these problems?????????????????He is also concerned about the hazard of this tower being struck by lightening. He says he does not want a 240 ft. lightening rod stuck in his front yard. What about the aviatation problem of these small planes hitting this tower ?????? Also concerned about the interference of a 2-way radio or antenna television reception... What security are you going to have for that tower, there shouldn't be any neighborhood kids playing on this tower. Also no one wants to live under this tower with a big red blinking light going all the time, who could sleep with that going on.

2. Dwight Hadley, Head of the Russell County Health Department. He informed Ms. Grider that these cellular towers were popping up everywhere and causing a lot of health problems. He said these towers can and will cook you, and cause cancer, just like the electric lines are causing cancer, so are these wireless cellular towers causing cancer. *phones*

3. Herman Knight: Owner, Knights Body Shop - Jamestown, KY. Former Employer of Andrew Antle, stating that he had to fire him because he wouldn't work and would not do his job, said he got tired of paying him to do nothing.

4. Ralph Roy, President of Ralph Roy Real Estate. The property of Janice Grider & Gary Grider 31 acres of prime time private property covering several hundred feet of highway frontage on highway 127 and also Damron Creek Road before the 240 ft. tower is erected is worth approximately \$ 50,000. Per Acre and this same property value after the 240 ft, tower is erected would be worth approximately \$ 5,000. per Acre.

5. JOYCE FAYE PASSMORE, daughter of Ernest Crew who lives across the road from the future sight of this 240 ft. tower on Damron Creek Road which is in the 500 ft. range of this tower. Her concerns are for her father, Ernest Crew, afraid the tower will cause him to get cancer. Also, concerned about the big red light flashing all the time, the interference of antenna tv and 2 way radio. Also concerned about the small planes hitting the tower, and 240 ft. lightening rod across the road, not to mention this is tornado alley. Has questions about the property value going down from what it is now.

6. Dorothy Murphy, good neighbor and good friend and she also has several un-answered questions and concerns about the health concern about radiation and cancer. She thinks cellular phones causes cancer. Now she is concerned that this microwave cellular tower is going to cause cancer to her if she comes to visit me. Also concerned about 240 ft. lightening rod, and the flashing red light . Also will this interfere with antenna tv or 2 way radio, and cordless phones

(Not cellular).

Like I said earlier in my letter , this is really not enough time to get all of this information together in 10 days and I am requesting an extension of more than 10 days , 30 days would really help more, since I'm no lawyer and I'm representing myself. I have never been on the inside of a courtroom in my life and I don't appreciate of having to do this for such a ridiculous issue. I don't like cellular phones, wouldn't have another one ever the rest of my life. Bluegrass Cellular gave me a dirty deal 10 years ago and that done me in on cellular anything, phones, towers, etc. Like I said in my previous letter, I had a bad experience with Bluegrass Cellular, I paid \$43 each month for 2 or 3 years and I did not use this phone, but one day my car broke down 5 miles out of my jurisdiction and I made one emergency phone call and Bluegrass Cellular charged me \$25.00 for that one and only phone call that I made in 3 years on that dam cellular phone.


In further checking FCC has a list of 25,807 results and they can't all be good results.

WHEN YOU FURNISH ME WITH THEIR NEW ADDRESS, I WILL BE HAPPY TO MAIL THEM A COPY OF THIS LETTER. Furthermore, whatever feedback I get from all these people I will be happy to send you a copy.
