
**JOINT MOTION OF JOHNSON COUNTY GAS COMPANY, INC., BUD RIFE,
AND COMMISSION STAFF TO MODIFY PROCEDURAL SCHEDULE**

Johnson County Gas Company, Inc., Bud Rife, and the Staff of the Public Service Commission of Kentucky (collectively, "Movants"), hereby move the Commission to modify the procedural schedule in this proceeding by canceling the hearing currently scheduled for September 22, 2006. In support of this Motion, Movants state that they have conducted settlement discussions and a settlement conference by telephone and have reached an agreement for resolving this proceeding; however, Movants have not yet completed drafting the settlement agreement. Due to the proximity of the currently scheduled hearing, Movants move the Commission to cancel the currently scheduled hearing to allow Movants time to complete drafting and executing the settlement agreement for presentation to the Commission.




