Sirs: Duke Energy does not deserve the electric rate increase it is asking for. The old Union LH&P should be sold to Kentucky Utilities and not an out-of-state company! KU electric rate for Lexington is .04720 per KWH and LG&E is .05955 per KWH. Why should Duke get .081299 per KWH? As stated in the Cincinnati Enquirer, Duke gives lousy electric service to Ryland Heights, Morning View, Visalia, Piner, and Fairview.
