ORDER

This matter is before the Commission as a result of a Notice of Termination of Wholesale Water Service issued by the Wood Creek Water District ("Wood Creek") to the city of Livingston ("Livingston") for nonpayment of outstanding invoices.

On May 4, 2006, the Commission entered an Order preventing the termination of Wood Creek's wholesale water supply to Livingston until such time as a hearing could be held in the matter. Said hearing was held before the Commission on May 23, 2006 and, after a brief recess, it was announced that Wood Creek and Livingston had reached an agreement.<sup>1</sup> On May 31, 2006, the Commission received another Notice of

<sup>1</sup> The terms of this agreement were:

1. Livingston would pay to Wood Creek the sum of \$10,194.88 on or before May 26, 2006 in full satisfaction of its outstanding balance.
2. Livingston would henceforth remain current in the payment of its bills for water service that Wood Creek provides.
3. Wood Creek and Livingston would negotiate during the next 6 months on the transfer of Livingston's water distribution and sewer facilities to Wood Creek.
4. Livingston would allow Wood Creek access to its financial records and documents and permit Wood Creek to make physical inspection of its water and sewer facilities.
5. Nothing in the agreement would obligate Wood Creek to purchase any facilities from Livingston or Livingston to sell any facilities to Wood Creek.

Termination of Wholesale Water Service issued by Wood Creek to Livingston, indicating that Livingston had failed to satisfy the terms of the May 23 agreement.

By Order dated June 2, 2006, the Commission scheduled a hearing for June 13, 2006 for the purpose of presenting evidence and argument on the proposed termination of water service to Livingston. Wood Creek has now advised, however, that Livingston has tendered payment of its delinquent bill and that Wood Creek does not intend to terminate Livingston's service. Based upon the most recent representations of Wood Creek, the Commission finds that good cause exists to cancel the June 13, 2006 hearing.

IT IS THEREFORE ORDERED that the June 13, 2006 hearing in this matter is cancelled.
